- C. Oral and Written Communications Staff noted that item E.1 had been withdrawn and distributed the revised Zoning Code sections.

- E. Individual Case Review
  - 1. Withdrawn
  - 2. <u>ADM10-0024, Fire Repair and Proposed Changes to an Historic Apartment Building at 405 North Juniper Street</u>

Applicant: Eric Fotiadi & Associates, 1940 5<sup>th</sup> Avenue, San Diego, CA 92103 Planner: Paul Bingham

Staff described the history of the craftsman style farm house that was built in 1910 and indicated the existing residence was not located in the Old Escondido Neighborhood but was a significant historic structure. Staff indicted that the project was to rehab the

Changes to the building included removing the added stucco, replacing the siding with like siding, changing the windows to period appropriate type and material, redesign and replace the existing stairwell that was added when the structure was converted to apartments. The new stairwell would allow for additional parking and provide some privacy for the bathroom windows. A patio cover proposed for the northwest side of the building would provide shade for the lower apartment unit. Staff also indicted new wiring; plumbing and a roof would be installed. Staff recommended approval of the project as proposed.

Board member Diefenbach felt that the project was a huge, but beneficial, undertaking and that the colors should be reviewed by the board. Board member Watson urged the applicant to re-landscape the property. Board member James felt that a wooden staircase would rot too quickly and that at a minimum the staircase should be painted. Board member Laguna clarified that the roofline was not changing and that the existing shade structure was to remain. Board member McArdle felt that the posts used to support the stairs and patio cover were too thin and not in of scale. He thought that more craftsman detail was needed to the columns and suggested paired columns for more substance. Chairman Bell confirmed that the siding would be replaced with all new 6" width siding.

**MOTION:** Moved by R. James, seconded by C. Laguna to approve the project with the condition to redesign the columns to be more craftsman style for the stairs and patio cover.

## 3. ADM10-0017, Enclose an Additional 380 SF Existing Trellis Area and new Colors, M-1 Zone, 490 Corporate Drive

Applicant: Pacific Cornerstone Architects,

Planner: Darren Parker

Staff described the exterior façade remodel to an existing industrial office building to include enclosing 380 SF under the existing entry feature, replacing all of the windows with dual glazing, adding a new ADA path of travel, providing a solid roof cover over the trash enclosure, adding landscaping trellis elements to the side of the building, and using a new palette of paint colors. Staff recommended approval of the project as submitted.

Board member McArdle confirmed sufficient on-site parking would be provided with the additional square footage being added. Chairman Bell confirmed the location of the new entry door.

Staff indicted that a joint meeting with the City Council was scheduled for March 17<sup>th</sup> at 3:30p.m. to interview applicants for the Design Review Board.

- H. Board member Discussion Board member Diefenbach indicated that the roof screen on the new Police and Fire Facility was not painted. She suggested continuing the colors from the front parapet around the corner across the roof screen, with a green stripe near the top and similar wall color. Board member Watson indicted that the bus storage facility project at the corner of Quince and Washington looked good.
