ORDINANCE NO. 2005-13

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ESCONDIDO EXTENDING THE TIME LIMITS OF THE ESCONDIDO REDEVELOPMENT PLAN BY ONE (1) YEAR FOR EACH OF THE TIME LIMITS RELATED TO (1) THE TIME LIMIT FOR THE EFFECTIVENESS OF THE ESCONDIDO REDEVELOPMENT PLAN, AND (2) THE TIME PAYING INDEBTEDNESS OR RECEIVING TAXES FOR THE **PROPERTY ESCONDIDO** REDEVELOPMENT PLAN PURSUANT TO CALIFORNIA HEALTH AND SAFETY CODE SECTION 33333.6(e)(2)(C)

WHEREAS, this Council has previously activated the Community Development Commission of the City of Escondido (the "Agency") and this Council by Ordinance No. 84-85, as amended from time to time, has adopted the Escondido Redevelopment Plan (the "Redevelopment Plan") for the Escondido Redevelopment Project (the "Redevelopment Project");

NOW, THEREFORE, the City Council of the City of Escondido does ordain as follows:

SECTION 1. (a) FINDINGS. This City Council hereby finds and determines that the Agency has been required to make a payment pursuant to California Health and Safety Code Section 33681.9 to the Educational Revenue Augmentation Fund from taxes allocated to the Agency for the Redevelopment Project. The existing time limits required by California Health and Safety Code Sections 33333.6(a) and (b) are contained in amendments to the Redevelopment Plan for the Redevelopment Project set forth in Ordinance No. 84-85, and CDC 94-1. The limit set forth in CDC Ordinance No. 94-1 are hereby ratified and affirmed subject to the extension set forth in the Ordinance or any other amendment to the Redevelopment Plan. This City Council hereby finds and determines that the enactment of this ordinance is exempt from the California Environmental Quality Act (Public Resources Code section 21000 et seq.) ("CEQA") pursuant to CEQA Guidelines Section 15378(b)(4) (California Code of Regulations Section 15378(b)(4)) because it is a fiscal activity which does not involve any commitment to any specific project which may result in a potentially significant

impact on the environment. The City Clerk is hereby authorized to file a Notice of Exemption with the County of San Diego pursuant to CEQA Guidelines Section 15094.

SECTION 2. Pursuant to California Health and Safety Code Section 33333.6(e)(2)(C), this City Council hereby amends the Redevelopment Plan for the Redevelopment Project to extend the time limits required pursuant to Health and Safety Code Sections 33333.6(a) and (b) by one (1) year.

SECTION 3. The Amendment to the Escondido Redevelopment Plan made pursuant to this Ordinance amends the text of the Redevelopment Plan addressing these limitations. This Ordinance amending the Redevelopment Plan is adopted pursuant to Health and Safety Code Section 33333.6(e)(2)(C) with the full force and effect provided therein, and pursuant to which neither the City Council nor the Agency is required to comply with Section 33354.6 of the California Health and Safety Code or Article 12 of the Community Redevelopment Law (Health and Safety Code Section 33000 et seq.), or any other provision thereof relating to the amendment of redevelopment plans.

SECTION 4. NO IMPAIRMENT. This Ordinance shall not be construed to affect the validity of any bond, indebtedness or other obligation, including any mitigation agreement entered into pursuant to Section 33401, authorized by the legislative body, or the Agency pursuant to the Community Redevelopment Law, California Health and Safety Code Section 33000, et seq., prior to the Effective Date of this Ordinance, and neither shall this Ordinance be constructed to affect the right of the Agency to receive property taxes, pursuant to Section 33670, to pay the indebtedness or other obligation.

SECTION 5. EFFECTIVE DATE. This Ordinance shall take effect thirty (30) days from the date of its passage and adoption.

SECTION 6. SEVERABILITY. If any part of this Ordinance is held to be invalid for any reason, such decision shall not affect the validity of the remaining portion of this Ordinance, and the City Council hereby declares that it would have passed the remainder of this Ordinance, if such invalid portion thereof had been deleted.

SECTION 7. CERTIFICATION. That the City Clerk is hereby directed to certify to the passage of this ordinance and to cause the same or a summary to be published, in accordance with Government Code section 36933, to be published one time within 15 days of its passage in the Times Advocate, a newspaper of general circulation, printed and published in the City of Escondido.
