City Council Meeting

I am happy to see that Chief Varso is looking at key indices at improving the selection, retention, and on going training of officers in the Escondido Police Department. I offer the following suggestions that merit his serious consideration, and that of the city council, in his attempt at improving the department.

1. Officer Hiring - I'm not completely clear on recruitment efforts from within the city of Escondido. It's just not big enough to generate an adequate pool of highly qualified law enforcement candidates. If the idea is to recruit the most desirable candidates, the larger the pool, the better the chances for attracting the most qualified candidates. Perhaps an incentive for moving into Escondido once a hiring decision is made would result in the desired outcome. Particular attention should be paid to attracting candidates fluent or competent in Spanish, as well as having a police department that is reflective, in terms of ethnicity, to the city.

2. Training Programs - One of the greatest challenges facing policing today. However, I have a problem calling the issues listed as "training issues". If the definition of **training** is acquisition of a skill through repetition, topics such as racial bias issues, cultural awareness, and mental health issues should not be included. These topics should be classified as **education** issues. If the definition of education includes understanding through learning, then I suggest that hiring considerations include a candidate with a strong educational background in the social sciences. Law enforcement is one of the most important career choices that requires a working understanding of social issues; a job where a strong social science background could make a big difference in a successful hiring decision. In line with the issues of a broader in-service educational experience, I suggest that members of the Escondido Police Department attend the Tools for Tolerance Program offered at the Museum of Tolerance in Los Angeles. The program is designed specifically for California law enforcement officers and is cost-neutral for the department. Costs are covered by POST, including overtime replacement costs.

3. Data Disclosure - I suggest that the topic of Citizen Complaints be included. Within this topic, which should be broken down into those complaints that include the subtopic of Use of Force - among other subtopics - and should include (without necessarily publicly naming the accused officer) the outcome of the complaint. An annual report should be required which would include an analysis of complaints that might indicate a pattern of troubling conduct. Perhaps this is already a department practice, but I don't know.

4. Outreach Practices - I applaud the Chief for including the topic of Community Policing among this overview. But I don't know why the Chief includes **Community Policing** as an outreach practice. My understanding is that community policing is more of a philosophy of management which includes policies and procedures that greatly includes input from the community as well as from the entire department, from the street officer up to and including the chief. In other words, it is more of a philosophy of inclusion and input from every stakeholder within and outside the department. Unless there has been a huge tectonic shift in the operations of this department, I doubt that this is happening but would love to see it.

5. Civilian Oversight Committee - In line with the philosophy of Community Policing, Escondido should create a Civilian Oversight Committee whose responsibilities, as the name suggests, is having another set of eyes looking at the police department's practices, policies, and planning. This topic is one that should be reserved for an entire meeting, but the suggestion of having such a city committee falls well within the philosophy of Community Policing. I would be happy to make myself available to discuss these and other issues with Chief Varso. - Bill Flores

Our family built a granny flat on our almost one acre property in South Escondido to help provide additional housing for our community. We rely on the rental income to help pay our mortgage and the cost of doing so, especially now during this pandemic. We are not wealthy.

Our tenant has been receiving the Cares Act Unemployment benefits extended through July 31 (with \$600 additional income Per Week). However, Since the Council created the Rent Moratorium for Escondido? they have simply decided to not to pay their rent.

They have not provided any verifiable documents to show financial hardship and have not returned our calls to discuss setting up a payment plan or agreement for the back rent they now owe. They are attempting no contact.

The rent moratorium has created financial hardship for our family in having to cover the loss of rent for our granny flat -For Months. This Cannot Go On Forever. We will be facing Foreclosure on our property. If Your intention was to safe guard Escondidans from homelessness? We will all be homeless, renters and landlords alike.

Please understand, we are acting in good faith and understand the current difficulties we all face. We do not intend eviction. But we cannot continue to take on the financial brunt of Escondido's management of this pandemic with the cost of our personal property being lost to the banks!

If you wish to help tenants pay their rent, then pay their rent for them. Do not do so at the cost and livelihood of other members of Our Community, tax paying property owners.

We ask the Council Members to please Not vote to extend the rent moratorium past the already four and a half month long term, so our family can attempt to recover financially from the loss of income it has created, and allow us some leverage to negotiate, in hopes of saving our personal property from the foreclosure we now face!

Comments I have been living next to someone who would have been evicted if the moratorium happened one week later. This person has been squatting in an apartment that shares a common wall with me since his mother moved after terminating her lease at the end of December. He has been in and out of prison, has had innumerable people living on the property, dealing drugs, smoking meth in our common laundry room, having "red light" parties, people urinating outside, living in the garage, fights that involve machetes, bats, and as recently as a couple of weeks ago, someone trying to stab another outside my front door. BBQs and drug parties that devolve into fighting start as early as 6 am and continue sometimes for several days. There is no masking, no social distancing. They have broken into cars and broke into my neighbors home, which they told him about. He would not report it because he is afraid of retribution. At first my neighbors warned me not to call the police because they would probably harm me and we were waiting for the eviction to rid us of these people, although calls were made to no avail. I have called The police several times, other neighbors have called for domestic violence, etc, but no matter how many times the police are called, with the no bail,situation, if anyone is taken away, they are back within hours. These people have never paid rent, were never on the lease and have been allowed to terrorize the people who live here because of the eviction moratorium. I am not opposed to the moratorium for those who are unable because of covid to pay their rent, but this situation is not like that. The property manager has done all that he can do legally to evict these people. We are not safe with this element here. When I have asked them to even wear masks, I have been called a pejorative for women, flipped off, and of course no masks or social distancing outside my front door. There needs to be something built into the moratorium if it is to continue to alleviate situations like this. This has given me PTSD because I do not feel safe in the home I have had for over 12 years, and at 70 in a pandemic cannot move nor should I have to. I need relief other than being placated by the police when they come out and do nothing other than occasionally taking someone away for a couple of hours. This is an untenable situation that the City Council can rectify by writing the moratorium to allow for evictions for this type of situation. The common good is not served by allowing criminals to run rampant. All citizens of Escondido need to be taken into account if you are going to extend the moratorium.

I write to you to consider my proposal (see attachment below) to unify Escondido by addressing the circumstances surrounding and the effects of the Escondido City Council's and Police Department's conduct regarding the targeting of Escondido's Latino community during the years 2005 through 2010 and beyond. Beginning in 2005, the Escondido City Council began an open attack on the city's Latino community through the formal endorsement of an anti-Latino, anti-immigrant ballot initiative; to passing unlawful city ordinances attacking the immigrant population; to making racist remarks from the dais and encouraging similar remarks from the public; to failure to properly supervise the City Manager and City Attorney resulting in an unlawful police action (Driver's License Checkpoints); to a windfall of millions of dollars to the city from the unlawful checkpoints and towing of vehicles; to allowing a uniquely close relationship with immigration authorities which ultimately lead to the separation of families and undue hardships upon the city's Latino community, I submit this proposal for your consideration and action.

With the change in leadership on the council I am hoping that you might see the justice and benefit in finally addressing this situation that bore heavily on this large segment of our city. The city has had time to move beyond the days of turmoil and pain inflicted on our important Latino community, but has yet to formally recognize what happened, apologize, and consider making some sort of restitution to what had been inflicted upon our neighbors. While I realize that this proposal is out of the ordinary, our country, in fact, is experiencing a time of reckoning and self-reflection like never before. Escondido's history of exclusion and bias goes far beyond it's city limits. In order for this city to heal, within it's border and beyond, we need to address what happened and to take affirmative steps to formally recognize the injury inflicted on the Latino community, how it happened, then move forward with an open hearts and an open government with the assurance that this kind of conduct will never happen again.
