Comments I'm Anzy, an organizer with the San Diego Party for Socialism and Liberation. I'm a resident of San Marcos and I attended high school at Classical Academy in Escondido. I'm writing to ask that officer Chad Moore from EPD be held accountable for the murder of homeless community member Steven Olson. We want officer Chad Moore terminated and charged for his crime. We demand that Escondido implement an independent police oversight committee to ensure there is some kind of check on the police power to kill community members with no consequences. Finally, we demand that funds be reallocated from policing toward services for the community such as housing, healthcare, mental healthcare and education. I watched the video released as a result of community protests and it was clear to me that officer Moore could have deescalated the situation and chose to use lethal force instead. It was also clear that Mr. Olson was experiencing a mental health episode and was not responsive or verbally communicative at the time. I believe it's not only this one killer cop who is responsible for the incident, but the political culture of the entire city which prioritizes punishing homelessness and poor mental health instead of funding community services to help. Letting community members suffer and live on the streets is violence. I hope that this unfortunate incident will be a wake up call to the city that we need to address the root cause of homelessness rather than continuing to act punitively and violently toward people in the community who need our help.

Mental health is important at every stage of life, from childhood through adulthood. It affects how we think, feel, and act. All drugs but especially marijuana, have increased the risk of developing mental illness. Quoting from the Psychiatric Times article titled Cannabis 2021: What Clinicians Need to Know in, "The acute and chronic problems cannabis-dependent individuals face is serious and disheartening. National Survey on Drug Use and Health data on 505,796 Americans show individuals aged 12 to 17, who met criteria for a cannabis use disorder were 25% more common in states that had enacted recreational marijuana laws as opposed to those who did not." Marijuana use directly affects the brain, specifically the parts responsible for memory, learning, attention and reaction time. Numerous studies have shown the real and damaging effects it has on the human brain. Marijuana use is associated with a six-fold risk of suicide and five-fold risk of developing psychosis. Given the myriad risks of marijuana use to mental health, please be cautious as you consider allowing marijuana businesses in the city.

Dear Mayor and Council -

Before you on May 12th is a project application in which we have a vital interest – Casa Mercado, a 120-unit apartment development.

We are the owners of two of the eleven lots which underly the project; they are at the corner of Quince and Third. For 52 years we operated a restaurant - Estrada's Mexican Food - on the site. The restaurant has been our sole source of income. In 2018 we signed agreements to sell the lots to Paul Mayer. Maria, already being fully retired, agreed to sell her property outright. Guillermo and Lily needed to follow a different course. They were anticipating retirement but needed to establish a means of providing an income stream during retirement. To meet that need, they agreed to sell their two lots but chose to use the proceeds to become minority partners in the project and receive incremental payments from the revenue generated by the completed apartments. This meant that their returns would be spread out over their retirement years – the only source of income for them.

Lily and Guillermo had hoped to keep their restaurant in operation until construction of Casa Mercado commenced. However, due to health concerns and new job plans for their adult children who were assisting in the restaurant, it became necessary to close the business for good on October 31, 2019. Since that time, Mr. Mayer has actually been advancing the monthly payments expected to be made from the finished project. Of course, that means that future payments will have to be reduced accordingly.

All of this makes approval and development of Casa Mercado critical for us as a family. When the plans for the project were first presented to us, it seemed like such a logical and desirable use of the 11 parcels of land that it never occurred to us that the project might not be approved and developed. We relied on that assumption in building our retirement plans around the project and they now hang in the balance. Even leaving aside our personal financial interest, we still believe this apartment project, oriented to Escondido residents with moderate incomes, makes perfect sense in this location. For all of these reasons, we can't urge too strongly the importance of approval. City of Escondido May 7, 2021 Page Two

Mr. Mayer has explained that there are also two issues related to the project approval. One, as we understand it, is the possibility that the project will be required to bear significant very recently imposed financial assessments that will make it unviable. However, the processing of plans and the arrangement of financing for this project were initiated and settled far earlier than the onset of the assessment plan. We're told that a similar larger project has been exempted from the assessments as a so-called "pipe-line project" and we believe that Casa Mercado should receive a similar exemption. The other issue relates to the fact that five of the 11 land parcels for the project are being acquired from the City and there is concern that the terms of the purchase agreement may be changed if the project is exempted from the financial assessments. The Casa Mercado project has been in the works for almost four years and its cost has already been escalated by delay. Mr. Mayer has made it clear that any further escalation of the land-cost will make the project infeasible.

In summary, we sincerely believe Casa Mercado would be an ideal use for the property that our family has owned for so many decades and hope that it will receive Council approval.
