Item 7 – Patricia Borchmann

I am a member of the Escondido Community Advisory Group (ECAG) Subcommittee that was formed to address the Escondido Climate Action Plan (ECAP). Our group was recently reactivated, so we are reenergized and excited to provide manpower, support and hands-on help to accelerate the next phase of the ECAP implementation to combat climate change. The ECAG Subcommittee is proud of the high quality Climate Action Plan that the City Council adopted in 2021, and are encouraged that the City hired a skilled policy planner, Veronica Morones to manage the next phase to ensure the ECAP's successful completion.

Our group met on Monday April 6, 2022 to develop a list of top priorities to combat climate change which members identified, to support the city in ECAP implementation.

The Staff Report indicates an action item for City Council is required tonight on the 2021-22 Climate Action Plan Annual Monitoring Report, to **recommend implementation milestones** for the forthcoming year, (2022-23). Therefore, we ask that you consider preliminary recommendations by ECAG Subcommittee, to adopt as milestones to reflect top priorities, as outlined below.

- 1. Creation of the Climate Commission
- 2. Pursue plans and grant funding for Urban Forest and tree planting goals
- 3. Development of the Zero Waste Plan including developing a single-use-plastics ban
- 4. Food Justice and Sustainable agriculture
- 5. Development of Cooling Centers
- 6. Development of the Energy Equity Plan.

We also observe that potential grant funding opportunities in 2022 reached unprecedented record levels by state and federal funding agencies, with funding levels in the millions, (some without matching funds), to target disadvantaged communities, to provide urban forest, and reduce urban heat islands. Some grants have guidelines, based on criteria that are already consistent with Escondido Climate Action Plan, with priority investment neighborhoods (PINs), in disadvantaged communities that are defined by Cal Enviro screen precincts. The stakes are huge since the potential return on investment (ROI) has never been higher, and Escondido cannot afford inaction. Since the 2022 grant cycle deadlines recently expired, ECAG Subcommittee recommends City Council **elevate** future grant funding to the top level, and assign adequate resources to assist senior staff to prepare future application(s) for appropriate grant funds.

We strongly urge you to maximize efforts to **compete** for major revenue from grant funds due in early 2023. Implementing the ECAP commitment to resilience, urban forestry, sustainable development, cooling centers and community equity are essential, so these worthy priorities can be supported through these grant funds. I am providing a summary of grants from state and federal agencies, prepared by the Climate Action Campaign attached. I've also distributed a sample of a grant fund announcement from one of the agencies that do not require matching funds, as an example, to motivate elected officials to take strong action.

Please set these priorities in your 2022-23 goals.

Good Evening Mayor and City Council Members,

As an active member of the community group that put together the Climate Action Plan. I regret that I cannot be there in person to speak about the importance of moving forward with the implementation of the Climate Action Plan. I know that the Plan is ambitious, but the urgency of the threat to our health and that of our environment calls for bold action and leadership. One of the elements of the Plan I wish to speak about is the recommendation to embark on a serious urban forestry plan. The Climate and health benefits of trees are universally recognized as a relief to the rising summer temperatures we are experiencing. Trees provide a cooling effect and provide relief for residents who do not have access to AC. The cooling effect of a singly healthy tree equates to 10 room-sized AC units. Trees allow for soil and stormwater retention and absorb additional GHGs and air pollution. The good news here is that a number of urban forestry grants are available to communities wishing to participate in these programs. I urge you to exercise bold leadership in considering the implementation of the Climate Action Plan.
