Councilmembers--I'm a constituent in District 2, and I'd like to ask you to advocate on behalf of the California Center for the Arts. Freedom of Speech is something we cherish in this country...it's a keystone of our democracy, and nowhere is it more important that our public officials protect it than in artistic expression.

I understand the objections of some Escondidans to the piece, "A.P.A.B" in the Street Legacy exhibit. While several were offended, that controversy gave rise to dialogue about how police are viewed differently in the Black and Latino communities than they are in White communities. This is a conversation that we cannot have too often. I know how important it is to my fellow Escondidans of color. I also understand how Councilmember Morasco would support censorship and cutting funding to the CCAE--no Escondidan would be surprised by his response.

I've spoken with Mayor Mac directly about this issue (I was shocked at his assent with Councilmember Morasco at the last meeting). He made his point by asking me, "what if it were Nazi art?" I replied that if it was, I'd fully support it's exhibition. The issues of white supremacy and police violence MUST be discussed. We must never stop discussing them...and I much prefer an art exhibit to stimulate that discussion rather than the grim alternative. The Mayor has since expressed his support of free speech-but also maintained he did not support this particular work.

I'm certain that you, member of this Council support free speech and understand how a very large section of Escondido does not share the same sense of security and trust of police enjoyed by the more fair-skinned population. I hope that knowledge influences you. I would encourage you to ask your friends of color how they perceive this matter. But aside from that, the California Center for the Arts is a precious gem of culture, not only for Escondido but for the entire region, and we should do everything we can to see it thrive, and bring significant, current, new ideas to our community...and continued dialogue regarding the issues our community faces.

Please vote in favor of maintaining Escondido funding for the California Center of the Arts at--or above-it's current level of support.
