Appointment for City Council - District 3 -

I am grateful that the City Council continued this important Agenda item, to allow stakeholders time to preview candidate nominations, instead of taking immediate action to appoint a Councilmember to represent District 3. In Escondido public stakeholders want to see the vacancy filled by the most qualified candidate, who has practical experience, expertise and a history of applying independent decision-making skills.

While I would have preferred to see the District 3 vacancy be filled based on a Special Election (instead of a Council appointment), it seems this process at least considers public comments and recommendations made by public stakeholders. I am hopeful that is actually the case, and that the decision on this appointment hasn't actually already been made by at least two or more City Council members and the Mayor, to support Christian Garcia. It is notable that maximum campaign donations were made by candidate Ms. C. Garcia to election campaigns for Mayor Dane White and Councilmember M. Morasco. Similar observations are also noted that maximum campaign donations were made by Mayor Dane White and Councilmember M. Morasco to support Christian Garcia during her election campaign for Palomar College District 2 Trustee, and an endorsement by Councilmember R. Garcia. In my personal opinion, this appointment to fill the District 3 vacancy is critical to determine the future in Escondido, and decisions made should be based on ethics, sound land use and environmental considerations, instead of mutual agenda priorities, political favors, profile or familial relationship. Council decisions will have impacts on quality of life for years, even decades, and stakeholders want to see assurances that the impacts will benefit the community.

It is encouraging to see so many qualified applicants in competition to earn the appointment to undertake public service in Escondido. After having previewed the applications, the responses to questions, and viewing the candidates performance during interviews at the last City Council meeting, it is my personal recommendation for City Council to appoint one of the following candidates:
