## Community Assessment for Proposed Response Plan for Oak Creek

Dear Community Member:

You are invited to complete and return the attached community survey assessing interest in the Response Plan prepared by Oak Pond, LLC ("Oak Pond"), to address heavy metal- and petroleum hydrocarbon-impacted soil from localized areas of the single family housing development described as "Oak Creek," which is proposed for the area generally referred to as 815 Hamilton Lane, Escondido, California (the "Site").

The Site consists of approximately 42 acres of land located east of Felicita Road, south of Hamilton Lane, and on the east and west sides of Miller Avenue in San Diego County, California. Historically, the Site was used for agricultural, nursery, and wood-chopping operations. In addition, soil was imported to the Site from off-site properties. As a result, heavy metals (including arsenic) and total petroleum hydrocarbons came to be present in soil at the Site.

In order to address the presence of the heavy metals and petroleum hydrocarbons, Oak Pond, LLC, voluntarily entered into an agreement with the California Department of Toxic Substances Control (DTSC), pursuant to the California Land Reuse and Revitalization Act, to prepare and implement the Response Plan. The purpose of the Response Plan is to reduce contaminant concentrations in soil to below cleanup standards specified by residential human health risk criteria employed by DTSC. Under the Response Plan, heavy metal and petroleum hydrocarbon-impacted soil will be excavated from the Site, and transported for disposal at a licensed off-site disposal facility under DTSC oversight.

In addition, the Site is located down gradient from the Chatham Brothers Barrel Yard with respect to groundwater flow. Releases of hazardous substances from the Chatham Brothers Barrel Yard have affected groundwater. The hazardous substances include volatile organic compounds such as tetrachloroethylene (typically referred to as PCE) and trichloroethylene, which is referred to as TCE. Due to the Site's down-gradient location from the Chatham Brothers Barrel Yard, a deed restriction will be recorded on the Site title to prohibit the use of groundwater at the Site for any purpose.

DTSC's overall goal is to restore and protect the environment, in part by overseeing environmental investigation and cleanups. Your response to the community survey will help DTSC develop future public participation activities associated with this and other cleanup efforts. Please complete and return the attached community survey by Monday, April 6, 2015.
