The proposed facility also includes a ten-foot (10) long x fifteen-foot (15) wide x eightfoot (8) high, masonry block equipment enclosure adjacent to the wireless facility and painted/textured to match the existing walls.

A Minor Conditional Use Permit to install and operate nine (9) AT&T small cell wireless communication facilities in the public right-of-way, consisting of replacing an existing light pole with a new approximately 30.5 feet tall street light and mounting one canister type antenna (24-inches tall x 10-inches in diameter) on top of the light pole, and 13.4-inch wide

and/or boring is required to extend power and telco underground to the new facilities. Additional associated equipment is proposed to be placed in a small new underground concrete vaults (hand hole). The existing light fixtures would be upgraded to LED. Nine (9) locations generally located along Avocado Avenue, North Broadway.
