
Dear Sir:

In response to your query regarding any public health concerns that might be associated with a housing facility for unaccompanied children arriving in the United States, primarily from Guatemala, Honduras & El Salvador, my opinion is that these concerns are insignificant. The infectious diseases that may be present in children from these countries would possibly include tuberculosis (which would be screened, treated, and not much of a problem for kids actually), parasitic diseases (easily screened and managed without risks to others), head lice (common in any kids and easily managed), and hepatitis (again easily detected and managed). These issues would be monitored routinely by our excellent local health department and managed as we do for our nonmigrant populations. These children might also be susceptible to vaccine preventable diseases but would likely have received immunizations in their home countries. Of greater concern is the increasing incidence of vaccine refusal among San Diego resident families who falsely believe that vaccines present risks rather than benefits to their children. Failing to immunize presents a significant public health risk to all.

I am a former Deputy Assistant HHS Secretary for International and Refugee Health and a 23 year veteran of the US Public Health Service. I currently teach global health in the Graduate School of Public Health, but my opinions are not to be construed as official statements from San Diego State University. I do encourage interested parties to rely on consultations and opinions from our San Diego Department of Public Health regarding any public health concerns in our community.
