SUBJECT: Donation of Two Surplus Ambulances

**DEPARTMENT**: City Manager's Office

### **RECOMMENDATION:**

It is requested that the City Council approve the donation of two retired Ford ambulance vehicles to the Crown Firecoach Enthusiasts, Southern California Chapter.

### FISCAL ANALYSIS:

The value of these vehicles, if sold at auction, is approximately \$7,500 each (\$15,000 total).

### BACKGROUND / RECOMMENDATION:

The City of Escondido enjoys an ongoing relationship with the Southern California Chapter of the Crown Firecoach Enthusiasts, Society for the Preservation and Appreciation of Antique Motor Fire Apparatus in Amercia (SPAAMFAA), whose activities have benefitted the local community. This non-profit 501c3 organization, is involved in the acquisition and restoration of vintage fire equipment, which is then utilized for public service activities in parades, and special events such as car shows, holiday toy and fund raising events, and educational displays including Escondido's annual Cruising Grand Fire Truck and First Responder's Night. The Crown Firecoach Enthusiasts are responsible for fully restoring the Escondido Firefighter's Association's 1956 Ford and assisting with the restoration of the City's 1962 Ford Police car.

Currently, the City has two out-of-service paramedic/ambulances designated as surplus, which are stored at the Public Works Yard, and are slated for auction. (See attached photos). Mike McDonald, the Director and Founding Member of Crown Firecoach Enthusiasts has requested that the City donate these vehicles to the Crown Firecoach Enthusiasts to be utilized as "Mobile Public Event Command Centers" at future events in Southern California. Alternatively, the City could sell these vehicles, which have an estimated value of \$7500 each, at auction. Staff recommends that the City Council approve donating the two surplus Ford ambulance vehicles to the Southern California Chapter of the Crown Firecoach Enthusiasts, SPAAMFAA.

The grant funds for \$4,000 will be provided to the library to purchase graphic novels to expand their collection, host a graphic novel-themed event, and send a staff member for professional development opportunities at the American Library Association (ALA) annual conference.

### BACKGROUND:

Will Eisner Graphic Novel Grants for Libraries support and encourage public awareness of the importance of graphic literature, sequential art, and comics as a literary medium. The grant provides funding for the expansion of library graphic novel collections as well as the creation of graphic novel-themed events to generate interest and awareness. In 2015, the Escondido Public Library (EPL) added an Adult Graphic Novel (AGN) collection to the expansive children and teen-targeted titles. This immediately became the library's fastest growing collection in terms of collection size, number of checkouts, and reported community satisfaction.

EPL expanded upon this popularity with events targeted for adult comic readers, including *Free Comic Book Day*, *Adult Graphic Novel Book Club* (sponsored by a partnership with San Diego Comic Con International), *Dads & Donuts*, and the successful *2018 One Book*, *One San Diego* programming in partnership with KPBS that featured a graphic novel as the selected community reading title. EPL staff furthered awareness of the importance of graphic novels as adult literature by presenting panels at both New York and San Diego Comic Con.

The result of this high quality AGN collection, popularity of programs, and staff advocacy has been an increase in community demand for more titles and events. The Escondido Public Library will host a *May the Fourth Be With You Free Comic Book Day* event on May 4, 2019, from 1:00-3:00 p.m. While participants of all-ages are welcome, funding from the Will Eisner Grant will specifically provide

incentives for adult level giveaway comics, refreshments, and supplies needed to run virtual reality games and 3D printing demonstrations for adults. This is an excellent way to engage a traditionally underserved demographic of younger adults, many of whom rarely utilize public libraries. They will interact with library staff and our emerging technology while learning about other library events and resources.

Library staff continue to seek innovative means of adding value to the City at little or no additional cost through the application for grants. Since this funding will provide for materials and programming above and beyond the service for which we have contracted with Library Systems and Services, a budget adjustment is necessary to receive the funds and pass them through.

SUBJECT: California Library Literacy Services Families for Literacy Grant Application

<u>DEPARTMENT</u>: Communications & Community Services Department

### **RECOMMENDATION:**

It is requested that the City Council adopt Resolution No. 2019-09, to authorize the Director of Communications and Community Services, or her designee, to complete an application for \$60,000 from the California Library Literacy Services Families for Literacy Grant and execute grant documents on behalf of the City. It is also requested that the City Council approve the necessary budget adjustment to receive, track, and spend these grant funds.

### **FISCAL ANALYSIS**:

The program will have no impact on the General Fund and no matching funds are required. Funds of \$60,000 will be awarded for the purpose of expanding family literacy programming.

### **BACKGROUND**:

The Escondido Public Library has been a recipient of the California Library Literacy Services Grant since 1991. These funds have enabled the provision of high-quality literacy services to adults with basic English language proficiency who seek to improve their quality of life by enhancing their reading and writing skills. Thousands of community members have been served through this program since its inception. To learn more about Escondido Public Library's literacy services and watch a moving video with real tutors and learners visit <a href="https://library.escondido.org/adult-literacy.aspx">https://library.escondido.org/adult-literacy.aspx</a>.

In June 2018, the California Legislature approved an additional \$2.5 million annually for California Library Literacy Services to specifically support family literacy. Funds are earmarked for expanding the quality and reach of existing family literacy activities, developing new family literacy programming and services, and achieving the California Library Literacy Services mission to enable Californians of all ages to reach their literacy goals and use library services effectively. Updates to the guidelines surrounding Families for Literacy services have also expanded the reach of the program from serving just ages from birth to five years old to now reaching ages birth to 18 years old.

### Specifically, funds will be used to:

- Add four new family literacy program and outreach events to existing adult literacy programs such as the addition of Early Literacy and STEM/STEAM based programming for children ages 0-18 and their parents.
- Send Literacy Services staff, tutors, and learners to literacy-based conferences and training workshops that will be provided by the California State Library;
- Increase collaboration around family literacy services between the library and its community partners such as Escondido Union High School District, the San Elijo Lagoon Conservancy

and the Escondido Neighborhood Network group (part of the San Diego STEM Ecosystem) led by the San Diego Children's Discovery Museum and Fleet Science Center;

- Hire at least one additional part-time Literacy Associate and increase the hours of the existing Literacy Specialist to strengthen the library's capacity to deliver high-quality family literacy services to low-literate adults and their families;
- Expand the size and reach of existing family literacy programs
- Help low-literate adults develop confidence and skills in supporting their children's education;
- Create opportunities for families to develop a culture of positive learning experiences together on a more sustained basis.

These funds will enable library staff to expand the current program offerings, partnership opportunities, and outreach events available through literacy services. Library staff continue to seek innovative means of adding value to the City at little or no additional cost through the application for grants. Since this funding will provide for materials, staffing, training, and programming above and beyond that for which we have contracted with Library Systems and Services, a budget adjustment is necessary to receive the funds and pass them through.

**DEPARTMENT:** 

Finance Department

### **RECOMMENDATION:**

It is requested that the City Council adopt Resolution No. 2019-16 authorizing the Deputy City Manager/Director of Administrative Services to enter into a Public Services Agreement with Blue Heron Consulting and approve the budget adjustment for \$95,000 for Utility Billing software consulting services.

### **FISCAL ANALYSIS**:

The Public Services Agreement will use reserve funds from the Water Operating Fund of \$47,500 and the Wastewater Operating Fund of \$47,500.

### CORRELATION TO THE CITY COUNCIL ACTION PLAN:

This item relates to the City Council's Action Plan regarding Fiscal Management by improving efficiencies in the Utility Billing process.

### PREVIOUS ACTION

On August 12, 2015, the City Council adopted Resolution No. 2015-139 approving the Oracle bundled package for software, licensing, and implementation service costs to upgrade the existing Utility Billing/CIS software to Oracle's Customer Care and Billing product and authorized the Director of Utilities to execute necessary contracts to initiate the upgrade. This included a contract with Blue Heron Consulting to provide system integration services for the implementation of the software.

### BACKGROUND:

In 1999, the City Council approved the purchase of PeopleSoft Corp and SPL Corp Utility Billing system (Resolution No. 99-218). Oracle acquired PeopleSoft Corp in 2005 and SPL Worldgroup in 2006. The PeopleSoft/SPL software was supported on Windows servers for a number of years and several minor upgrades and maintenance were performed until 2006. Oracle stopped developing upgrades for the PeopleSoft/SPL version, and the underlying technologies were out of support for modern operating systems.

In 2015, Oracle offered the City a one-time incentive package to upgrade to Oracle's Customer Care and Billing (CC&B), their premiere billing and CIS product. The bundled package included reduced software and licensing costs from Oracle along with discounted implementation services from Blue Heron, a certified Oracle Gold Partner who specializes in installation, maintenance, and implementation of Customer Information and Billing systems for small and mid-sized businesses. The City has worked with Blue Heron in the past for CIS enhancements and business process reengineering. The value we received from that relationship was exceptional. Blue Heron is the only Oracle-certified partner in North America who responded to our RFI and met our qualifications.

With the assistance of Blue Heron Consulting, the City went live successfully with the upgrade to Oracle's Customer Care and Billing software in August 2016. However, technology upgrades and improved services Citywide require configuration changes to the current utility billing software environment.

In order to meet the project timeline and go live date, certain CC&B processes were identified as not functioning correctly but not critical enough to delay the go live date. These include an internal software interface with the City's financial software PeopleSoft Financials, general setup customizations, certain rate tables within the system, and various processes that are currently being completed manually that could be automated within the system.

In addition, on May 1, 2018, the City implemented a new payment website with Invoice Cloud and established a new printing and mailing vendor, InfoSend. As a result of implementing these new and improved services, processes in the billing, printing, and payment job streams have changed within the software that can be modified to function efficiently.

On August 22, 2018, the City Council adopted Resolution No. 2018-132, authorizing the purchase of the CityWorks program for various departments Citywide. In order to process Field Orders and communicate effectively and efficiently between departments, an interface between the CC&B Utility Billing software and the CityWorks software needs to be developed.

Blue Heron Consulting is the only company with the history and background required to complete the software configuration changes and enhancements listed in Exhibit 1, Attachment A to Resolution No. 2019-16. Furthermore, because the Blue Heron staff were an integral part of the software upgrade project completed in 2016, their knowledge of the City's current utility billing environment and customizations will streamline the project resulting in a timely and efficient completion of the identified tasks. Staff recommends approval of awarding the Public Services Agreement to Blue Heron Consulting as provided in Resolution No. 2019-16, as well as approval for a budget adjustment of \$95,000. This includes 648 consultant hours plus pre-approved travel expenses, if needed.

WHEREAS, the City Council desires it at this time and deems it to be in the best public interest to authorize the Deputy City Manager/Director of Administrative Services

to enter into a Public Services Agreement with Blue Heron in an amount not to exceed \$95,000.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California, as follows:

- 1. That the above recitations are true.
- 2. That the City Council accepts the recommendations of the Deputy City Manager/Director of Administrative Services.
- 3. That the City Council authorizes the Deputy City Manager/Director of Administrative Services to sign and execute the Public Service Agreement (attached as Exhibit "1" and incorporated by this reference) and other related documents with Blue Heron that may be required in the performance of the agreement.
- 4. That the Mayor and City Council approve a budget adjustment in the amount of \$47,500 from the Water Operating Fund and \$47,500 from the Wastewater Operating Fund for the services

WHEREAS, the CITY and CONTRACTOR desire to enter into this Agreement for the performance of services;

NOW, THEREFORE, it is mutually agreed as follows:

- 1. <u>Description of Services</u>. CONTRACTOR will furnish all of the services described in the Statement of Work, which is attached and incorporated by this reference. CONTRACTOR agrees to diligently perform such services to their completion, with professional quality and technical accuracy.
- 2. <u>Compensation</u>. The CITY will pay and CONTRACTOR will accept in full payment for the above work, the sum of \$95,000. Any breach of this Agreement will relieve CITY from the obligation to pay CONTRACTOR, if CONTRACTOR has not corrected the breach after CITY provides notice and a reasonable time to correct it. If this Agreement is amended at any time, additional compensation of CONTRACTOR contained in subsequent amendment(s) shall not exceed a cumulative total of ten percent (10%) of the maximum payment provided for in this Section 2.
- 3. <u>Term and Time of Performance</u>. CONTRACTOR must start working within one (1) week from City's notice to begin. CONTRACTOR must diligently perform and complete the work in accordance with the terms and conditions in the Statement of Work. Extension of terms or time of performance may be made only upon the City's written consent.
- 4. <u>Scope of Compensation</u>. CONTRACTOR will be responsible for performance of the tasks specified in the Description of Services in the Statement of Work. No compensation will be provided for any other tasks without specific prior written consent from the CITY.

- 5. <u>Performance</u>. CONTRACTOR must faithfully perform in a proficient manner, to the satisfaction of the CITY, all the work or services described in the Description of Services, above.
- City Property. All original documents, drawings, electronic media, and other material prepared by CONTRACTOR under this Agreement immediately becomes the exclusive property of the CITY, and may not be used by CONTRACTOR for any other purpose without prior written consent of the CITY.

### 7. Insurance Requirements.

- a. The CONTRACTOR shall secure and maintain at its own cost, for all operations, the following insurance coverage, unless reduced by the City Attorney:
  - (1) General liability insurance. Occurrence basis with minimum limits of \$1,000,000 each occurrence, \$2,000,000 General Aggregate, and \$1,000,000 Products/Completed Operations Aggregate; and
  - (2) Automobile liability insurance of \$1,000,000 combined single-limit per accident for bodily injury and property damage, unless waived as provided in 7(b) below; and
  - (3) Workers' compensation and employer's liability insurance as required by the California Labor Code, as amended, or certificate of sole proprietorship; and
- b. It is the parties' understanding that the use of a motor vehicle is not a primary subject of this Agreement. CONTRACTOR acknowledges that operating a motor vehicle is outside the scope of this Agreement and occurs only at the convenience of CONTRACTOR. A waiver of automobile liability insurance is only effective if both sets of initials appear below, otherwise such insurance is required.

- c. Each insurance policy required above must be acceptable to the City Attorney.
  - (1) Each policy must provide for written notice within no more than thirty (30) days if cancellation or termination of the policy occurs. Insurance coverage must be provided by an A.M. Best's A- rated, class V carrier or better, admitted in California, or if nonadmitted, a company that is not on the Department of Insurance list of unacceptable carriers.
  - (2) All non-admitted carriers will be required to provide a service of suit endorsement in addition to the additional insured endorsement.
  - (3) Both the General Liability and the Automobile Liability policies must name the CITY specifically as an additional insured under the policy on a separate endorsement page. The endorsement must be ISO Form CG2010 11/85 edition or its equivalent for General Liability endorsements and CA 20-01 for Automobile Liability endorsements.
  - (4) The General Liability policy must include coverage for bodily injury and property damage arising from CONTRACTOR's work, including its on-going operations and products-completed operations hazard.
  - (5) The General Liability policy must be primary and noncontributory and any insurance maintained by CITY is excess.

- d. In executing this Agreement, CONTRACTOR agrees to have completed insurance documents on file with the CITY within fourteen (14) days after the date of execution. Failure to comply with insurance requirements under this Agreement will be a material breach of this Agreement, resulting in immediate termination at CITY's option.
- 8. <u>Indemnification</u>. CONTRACTOR (which in this paragraph 8 includes its agents, employees and subcontractors, if any) agrees to indemnify, defend, and hold harmless the CITY from all claims, lawsuits, damages, judgments, loss, liability, or expenses, including attorneys' fees, for any of the following:
  - a. Any claim of liability arising out of the negligence or any acts or omissions of CONTRACTOR in the performance of this Agreement;
  - b. Any personal injuries, property damage or death that CONTRACTOR may sustain while using CITY-controlled property or equipment, while participating in any activity sponsored by the CITY, or from any dangerous condition of property; or
  - c. Any injury or death which results or increases by any action taken to medically treat CONTRACTOR.

Stormwater Indemnification. CONTRACTOR shall further indemnify, defend, and hold harmless CITY and its officers, employees, and agents from and against any and all liabilities, claims, actions, causes of action, proceedings, suits, administrative proceeds, damages, fines, penalties, judgments, orders, liens, levies, costs and expenses of whatever nature, including reasonable attorney's fees and disbursements, arising out of any violation, or claim of violation of the San Diego Municipal Storm Water Permit (Order No. R9-2013-0001), as amended or renewed, of the California Regional Water Quality Control Board Region 9, San Diego, which CITY might suffer, incur, or become subject by reason of or occurring as a result of or allegedly caused by the construction of the Project or the Improvements.

- 9. Anti-Assignment Clause. Since the CITY has relied on the particular skills of CONTRACTOR in entering this Agreement, CONTRACTOR may not assign, delegate, or sublet any duty or right under this Agreement, or any portion of the Description of Services. Any such purported assignment, delegation, or subletting will void this entire Agreement, unless the CITY has previously approved such action in writing. Unless CONTRACTOR assigns this entire Agreement, including all rights and duties herein, to a third party with the CITY'S written consent, CONTRACTOR shall be the sole payee under this Agreement. Any and all payments made pursuant to the terms of this Agreement are otherwise not assignable.
- 10. <u>Costs and Attorney's Fees</u>. In the event that legal action is required to enforce the terms and conditions of this Agreement, the prevailing party will be entitled to reasonable attorneys' fees and costs.

- 12. <u>Merger Clause</u>. This Agreement and its Attachments, if any, are the entire understanding of the parties, and there are no other terms or conditions, written or oral, controlling this matter. In the event of any conflict between the provisions of this Agreement and any of its Attachments, the provisions of this Agreement must prevail.

- 13. <u>Anti-Waiver Clause</u>. None of the provisions in this Agreement will be waived by CITY because of previous failure to insist upon strict performance, nor will any provision be waived because any other provision has been waived by CITY, in whole or in part.
- 14. <u>Severability</u>. The invalidity in whole or in part of any provision of this Agreement will not void or affect the validity of any other provisions of this Agreement.
- 15. <u>Choice of Law</u>. This Agreement is governed by the laws of the State of California. Venue for all actions arising from this Agreement must be exclusively in the state or federal courts located in San Diego County, California.
- 16. <u>Multiple Copies of Agreement/Counterparts</u>. Multiple copies and/or counterparts of this Agreement may be executed, including duplication by photocopy or by computerized scanning device. Each duplicate will be deemed an original with the same effect as if all the signatures were on the same instrument. However, the parties agree that the Agreement on file in the office of the Escondido City Clerk is the copy of the Agreement that shall take precedence should any differences exist among copies or counterparts of the document.
- 17. <u>Provisions Cumulative</u>. The foregoing provisions are cumulative and in addition to and not in limitation of any other rights or remedies available to the CITY.
- 18. <u>Notices to Parties</u>. Any statements, communications or notices to be provided pursuant to this Agreement must be sent to the attention of the persons indicated below. Each party agrees to promptly send notice of any changes of this information to the other party.
- 19. <u>Business License</u>. The CONTRACTOR is required to obtain a City of Escondido Business License prior to execution of this Agreement.
- 20. Compliance with Applicable Laws, Permits and Licenses. CONTRACTOR shall keep itself informed of and comply with all applicable federal, state, and local laws, statutes, codes, ordinances, regulations, and rules in effect during the term of this Agreement. This shall include, but not limited to, all California Labor Code laws regarding payment of prevailing wages and all OSHA regulations. CONTRACTOR shall obtain any and all licenses, permits, and authorizations necessary to perform the services set forth in this Agreement. Neither CITY, nor any elected nor appointed boards, officers, officials, employees, or agents of CITY, shall be liable, at law or in equity, as a result of any failure of CONTRACTOR to comply with this section.
- 21. Prevailing Wages. If applicable, pursuant to Section 1770 et seq. of the Labor Code, CONTRACTOR agrees that a prevailing rate and scale of wages, in accordance with applicable State and Federal Law, will be paid in the carrying out of this Agreement. CONTRACTOR shall keep itself informed of and comply with all applicable federal, state, and local laws, statutes, codes, ordinances, regulations, and rules pertaining to the payment of prevailing wages. The prevailing rate and scale to be paid shall be the same as the 'General Prevailing Wage Rates' approved by the Department of Industrial Relations as of the date of the execution of this Agreement. Said rates and scales are herein referred to and adopted in this Agreement as though fully and completely set forth herein, and said scale as adopted by the Department is made a part of this Agreement by reference. Copies of the prevailing rate of per diem wages are available on the Intranet at (http://www.dir.ca.gov/DLSR). Neither CITY, nor any elected nor appointed boards, officers, officials, employees, or agents of CITY, shall be liable, at law or in equity, as a result of any failure of CONTRACTOR to comply with this section.

22. Immigration Reform and Control Act of 1986. CONTRACTOR shall keep itself informed of and comply with the Immigration Reform and Control Act of 1986. CONTRACTOR affirms that as a licensed Contractor and employer in the State of California, all new employees must produce proof of eligibility to work in the United States within the first three days of employment and that only employees legally eligible to work in the United States will be employed on this public project. CONTRACTOR agrees to comply with such provisions before commencing and continuously throughout the performance of this Agreement.

### **BACKGROUND:**

At the December 19, 2018, City Council Meeting, Brady Bradshaw spoke during Oral Communications. Mr. Bradshaw provided information regarding a federal proposal to begin offshore oil drilling in the Pacific coastal waters. Mr. Bradshaw also provided information and statistics regarding the coastal waters impact on the economy, and the dangers of offshore oil drilling, pointing to the Deep Water horizon spill that occurred in Mexico, as an example of the negative impacts of an oil spill. The Deep Water horizon spill (also referred to as the BP oil spill/leak, the BP oil disaster, the Gulf of Mexico oil spill, and the Macondo blowout), was an industrial disaster occurring in April 2010, in the Gulf of Mexico and considered to be the largest marine oil spill in the history of the petroleum industry. At the conclusion of the meeting, Councilmember Diaz requested support from her colleagues to direct staff to prepare a Resolution opposing oil drilling off the coast of Southern California.

### RESOLUTION NO. 2019-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ESCONDIDO, CALIFORNIA, IN OPPOSITION TO FEDERAL OIL AND GAS LEASES IN ALL UNITED STATES WATERS, AND SPECIFICALLY OFF THE COAST OF CALIFORNIA

WHEREAS, City of Escondido residents value California state beaches and coastal waters, which provide habitat to a vast array of wildlife, including fish, whales, sea turtles, and birds that depend on a healthy and clean environment; and

WHEREAS, expanding offshore oil and gas drilling and exploration could threaten marine wildlife, human health, and the climate; and

WHEREAS, the federal government has proposed an expansion of offshore oil and gas leasing to new areas which have largely been off-limits to new federal leasing, including the Pacific Coast; and

WHEREAS, new federal offshore oil and gas leases have not been granted off the coast of California since 1984; and

WHEREAS, Pacific waters have long-standing military activities and the Department of Defense (DOD) has expressed concerns with developing oil and gas in some areas due to ongoing defense operations. For example, DOD classified areas off the coast of Southern California as off limits to oil and gas activity in order to preserve combat readiness training, ensure a sterile environment for live fire, and to maintain margins for Naval and Marine Corps operations; and

WHEREAS, the City of Escondido is opposed to inclusion of any offshore drilling tracts in any Outer Continental Shelf (OCS) Planning Area on the Pacific Coast and

U.S. Arctic in the pending 2019-2024 Proposed Program and any other future National Programs; and

WHEREAS, the State of California prohibited new oil and gas leasing in state waters due to the unacceptably high risk of damage and disruption to the marine environment; and

WHEREAS, the Governor of California, the Attorney General, the State Senate and Assembly, the State Lands Commission, the Coastal Commission, and Fish and Game Commission, the Pacific Fishery Management Council, along with a growing number of cities, have taken a stand against new federal offshore oil and gas leases in the Pacific Ocean; and

WHEREAS, opening new areas off California's coast to offshore drilling could deepen the state's dependence on fossil fuels and undermine its efforts to address climate change by reducing greenhouse gas emissions and moving toward renewable energy.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California:

- 1. That the above recitations are true.
- 2. That the City Council opposes new federal oil and gas leasing in all U.S. waters off the coast of California.
- 3. That the City Clerk shall send a copy of the approved resolution as a public comment from the City of Escondido to the Bureau of Ocean Energy Management (BOEM) 2019-2024 Draft Proposed Program (Docket ID BOEM-2017-0074) (Federal Register Number 2018-00083).

### **RECOMMENDATION:**

It is requested that the City Council adopt Resolution No. 2019-23 and 2019-24 authorizing two applications to SANDAG as part of the Regional Competition of the Statewide Active Transportation Program (ATP) as well as authorizing these projects to participate in a SANDAG TransNet/ATP funding exchange if funds are recommended on a regional basis and are available. The Director of Engineering Services or her designee shall be authorized to complete a grant to fund the Escondido Creek Trail Transit Center Bicycle Path Improvements Project and the Director of Community Development or his designee shall be authorized to complete a grant to fund the Escondido Comprehensive Active Transportation Strategy (CATS) Plan.

### **FISCAL ANALYSIS**:

The City has applied for \$976,000 in ATP funds in the ATP Cycle 4 round. ATP awards consist of State and Federal funds. If SANDAG recommends either of the City of Escondido applications in the regional competition, SANDAG may choose to substitute TransNet funds for the State/Federal Funds. Completion of a CATS Plan is included as an action item in the City's General Plan and Climate Action Plan and will make the City of Escondido more competitive for local, state and federal active transportation funding.

### CORRELATION TO THE CITY COUNCIL ACTION PLAN:

This item relates to the Council's Action Plan regarding Community Improvement and Public Safety.

### **PREVIOUS ACTION:**

On July 11, 2018, City Council authorized the Director of Engineering Services and the Director of Community Development or their designees to complete applications for Active Transportation Program (ATP) Grant funds and accept the grant funds and complete necessary grant documents.

The City of Escondido has received \$4,060,000 in funding for three active transportation projects under previous ATP cycles.

### **BACKGROUND**:

The ATP program was created by Senate Bill 99 (Chapter 259, Statutes of 2013) and Assembly Bill 101 (Chapter 354, Statutes of 2013) to encourage increased use of active modes of transportation. Senate Bill 1 (SB1) (chapter 2031, Statutes of 2017) stipulates that \$100,000,000 of revenues from the Road Maintenance and Rehabilitation Account will be available annually to the ATP. ATP goals include: increase biking and walking trips; increase the safety and mobility of non-motorized users; greenhouse gas reduction; enhance public health; and provide a broad spectrum of projects to benefit many types of active transportation.

After receiving authorization from the City Council, staff submitted two applications to Caltrans for ATP Cycle 4 grants for the Escondido Creek Trail Transit Center Bicycle Path Improvements Project (\$747,000 plus an \$80,000 local leverage) and an Escondido Comprehensive Active Transportation Strategy Plan (\$229,000 plus \$39,000 local leverage). The Escondido Creek Trail Transit Center Bicycle Path Improvements Project will include pedestrian signals, crosswalks, signage, ramps, lighting, and striping to improve the visibility and safety of pedestrians and bicyclists where the bicycle path crosses Tulip Street and Quince Street. The CATS Plan, building upon the 1999 Trails Master Plan, 2012 Bicycle Master Plan, Complete Streets Policy, and 2013 Climate Action Plan, will lay the foundation for improved bicycle and pedestrian facilities within the City and connecting between adjacent jurisdictions.

Funds are awarded as part of a statewide competition or a regional competition. Neither of these projects have been selected for funding in the statewide competition. SANDAG, as the local Metropolitan Planning Organization, is conducting a competitive selection process for the Cycle 4 distribution of ATP funds in the San Diego Region. If a project is recommended for funding in the Regional Competition, SANDAG may choose to substitute local TransNet funds for the State and Federal funds. The City Council is being asked to approve a resolution consistent with SANDAG Board Policy No. 035 to allow a TransNet/ATP swap, if applicable, in order to accept TransNet funds.

SUBJECT: 2019 City of Escondido Budget Process

**DEPARTMENT**: Finance Department

### CORRELATION TO THE CITY COUNCIL ACTION PLAN:

This item relates to the Council's Action Plan regarding Fiscal Management.

### **BACKGROUND:**

The City of Escondido's Operating and Capital Improvement Program (CIP) Budgets are management and planning tools that serve as an outline to how the City should best use its resources to benefit the citizens of Escondido. The Operating Budget projects short-term revenue and expenditures (employee services, maintenance operations, internal service charges and debt service payments) related to providing day-to-day services such as recreation programs, older adult services, streets, parks, police, fire, water and wastewater. The CIP budget projects long-term (five years) revenue and expenditures for major infrastructure and other capital construction, improvements and maintenance projects. The City Council provides policy direction for the framework for the annual budget development and implementation. Taxpayers benefit from the understanding of how their tax dollars are being spent and accounted for in the overall operations of the City.

The City strives to make the budget process and documents clear and useful to all users. ### **RECOMMENDATION:**

It is requested that the City Council adopt Resolution No. 2019-02 awarding the bid to Sancon Engineering Inc., determined to be the lowest responsive and responsible bidder; authorizing the Mayor and the City Clerk to execute a Public Improvement Agreement in the amount of \$841,310, and authorizing staff to approve change orders up to 20 percent of the contract value for the Storm Drain Pipe Lining and Rehabilitation Project Phase I ("Project").

### FISCAL ANALYSIS:

There are sufficient funds included in the adopted Capital Improvement Program (CIP) budget for the Storm Drain Pipe Lining and Rehabilitation Project Phase I.

### **BACKGROUND:**

On August 1, 2017, the City Council approved a contract with Brown and Caldwell to assess and survey the City's storm drain system. Brown and Caldwell televised and rated the condition of twenty miles of corrugated metal pipelines and summarized the findings in a report ranking the priority for rehabilitation. This Project will rehabilitate seventeen of the City's' most critical storm drain pipes. The project scope of work includes televising, inspecting, cleaning, point repairs, grouting of the existing flow line, and installation of new cured-in-place-pipe liner.

On January 10, 2019, five sealed bids were received in response to the advertised request for bids on this Project. The bid results are listed below:

Sancon Engineering Inc.	\$ 841,310.00
Downstream Services, Inc.	\$ 992,543.00
Iron Horse Pipeline Services	\$1,207,621.00
Insituform	\$1,858,443.00

The bid submitted by NU Line Technologies, LLC is considered to be non-responsive as it did not include the revised bid schedule provided with Addendum #1.

Staff recommends that the bid submitted by Sancon Engineering Inc. be considered the lowest responsive and responsible bid, and that the contract be awarded in the amount of \$841,310.00 to Sancon Engineering Inc. The lowest responsive bid is 12.6-percent higher than the Engineer's estimate of \$747,000.

Staff requests authorization to approve change orders up to 20 percent of the contract value. Portions of pipes to be repaired with this project could not be televised due to lack of access or blockages. For this reason, it is possible that additional work may be necessary to make full repairs. In order to avoid costs associated with delays in completion of the work, staff requests authorization to approve change orders up to 20 percent of the contract value, as work necessary may exceed staff's 10 percent authority.

Such protest shall not be effective unless reduced to writing and filed with the CITY within three (3) working days of the date of occurrence of the act or omission preventing the CONTRACTOR from fully complying with the Project documents.

- 3. CITY shall pay to the CONTRACTOR, as full consideration for the faithful performance of the contract, subject to any additions or deductions as provided in the Project documents, the sum of **Eight Hundred Forty-One Thousand Three Hundred and Ten Dollars (\$841,310.00)**.
- 4. The work shall be commenced on or before the twenty-first (21st) day after receiving the CITY'S Notice to Proceed and shall be completed within **One Hundred Twenty** (120) working days from the date specified in the Notice to Proceed.
- 5. Time is of the essence. If the work is not completed in accordance with Paragraph 4 above, it is understood that the CITY will suffer damage. It being impractical and infeasible to determine the amount of actual damage(s), in accordance with Government Code Section 53069.85, it is agreed that CONTRACTOR shall pay to CITY as fixed and liquidated damages, and not as a penalty, the sum(s) indicated in the LIQUIDATED DAMAGES SCHEDULE below for each calendar day of delay until work is completed and accepted. This amount shall be deducted from any payments due

- In the event CONTRACTOR, for a period of ten (10) calendar days after receipt of written 6. demand from CITY to do so, fails to furnish tools, equipment, or labor in the necessary quantity or quality, or to prosecute said work and all parts thereof in a diligent and workmanlike manner, or after commencing to do so within said ten (10) calendar days, fails to continue to do so, then the CITY may exclude the CONTRACTOR from the premises, or any portion thereof, and take possession of said premises or any portion thereof, together with all material and equipment thereon, and may complete the work contemplated by this Agreement or any portion of said work, either by furnishing the tools, equipment, labor or material necessary, or by letting the unfinished portion of said work, or the portion taken over by the CITY to another contractor, or demanding the surety hire another contractor, or by any combination of such methods. In any event, the procuring of the completion of said work, or the portion thereof taken over by the CITY, shall be a charge against the CONTRACTOR, and may be deducted from any money due or to become due to CONTRACTOR from the CITY, or the CONTRACTOR shall pay the CITY the amount of said charge, or the portion thereof unsatisfied. The sureties provided for under this Agreement shall become liable for payment should CONTRACTOR fail to pay in full any said cost incurred by the CITY. The permissible charges for any such procurement of the completion of said work should include actual costs and fees incurred to third party individuals and entities (including, but not limited to consultants, attorneys, inspectors, and designers) and actual costs incurred by CITY for the increased dedication of time of CITY employees to the Project.
- 7. To the fullest extent permitted by law, the CONTRACTOR agrees to and does hereby agree to fully defend, indemnify and hold the CITY, its governing board, officers, agents, Project design team members (architect and consulting engineers), consultants, attorneys, and employees harmless of and from each and every claim, assertion, action, cause of action, arbitration, suit, proceedings, or demand made, and every liability, loss, judgment, award, damage, or expense, of any nature whatsoever (including attorneys' fees, consultant costs), which may be incurred by reason of:
  - (a) Asserted and/or actual liability arises from claims for and/or damages resulting from damages for:
    - (1) Death or bodily injury to persons.
    - (2) Injury to, loss or theft of tangible and/or intangible property/ e.g. economic loss.
    - (3) Any other loss, damage or expense arising under either (1) or (2) above, sustained by the CONTRACTOR upon or in connection with the work called for in this Project, except for liability resulting from the sole active negligence, or willful misconduct of the CITY.
  - (b) Any injury to or death of any person(s) or damage, loss or theft of any property caused by any act, neglect, default or omission of the CONTRACTOR, or any person, firm, or corporation employed by the CONTRACTOR, either directly or by independent contract, arising out of,

or in any way connected with the work covered by this Agreement, whether said injury or damage occurs on or off City property.

(c) Any and all liabilities, claims, actions, causes of action, proceedings, suits, administrative proceedings, damages, fines, penalties, judgments, orders, liens, levies, costs and expenses of whatever nature, including reasonable attorneys' fees and disbursements, arising out of any violation, or claim of violation of the San Diego Municipal Storm Water Permit (Order No. 2001-01), and updates or renewals, of the California Regional Water Quality Control Board Region 9, San Diego, which the CITY might suffer, incur, or become subject by reason of or occurring as a result of or allegedly caused by the construction, reconstruction, maintenance, and/or repair of the work under this Agreement.

The CONTRACTOR, at CONTRACTOR's own expense, cost, and risk shall defend any and all actions, suit, or other proceedings that may be brought or instituted against the CITY, its governing board, officers, agents or employees, on any such claim, demand or liability, and shall pay or satisfy any judgment that may be rendered against the CITY, its governing board, officers, agents or employees in any action, suit or other proceedings as a result thereof.

- 8. CONTRACTOR shall take out, prior to commencing the work, and maintain, during the life of this contract, and shall require all subcontractors, if any, of every tier, to take out and maintain:
  - (a) General Liability and Property Damage Insurance as defined in the General Conditions in the amount with a combined single limit of not less that \$3,000,000 per occurrence.
  - (b) Course of Construction / Builder's Risk Insurance. See Article 5.2 of General Conditions.
  - (c) Insurance Covering Special Hazards: The following special hazards shall be covered by rider or riders to the above-mentioned public liability insurance or property damage insurance policy or policies of insurance, or by special policies of insurance in amounts as follows:
    - (1) Automotive and truck where operated in amounts as above
    - (2) Material hoist where used in amounts as above
  - (d) Workers' Compensation Insurance.
  - (e) Each insurance policy required above must be acceptable to the City Attorney, as follows:
    - (1) Each policy must name the CITY specifically as an additional insured under the policy on a separate endorsement page, with the exception of the workers' compensation and the Errors and Omissions policies.
    - (2) Each policy must provide for written notice within no more than thirty (30) days if cancellation or termination of the policy occurs. Insurance coverage must be provided by an A.M. Best's A-rated, class V carrier or better, admitted in California, or if non-admitted, a company that is not on the Department of Insurance list of unacceptable carriers.
    - (3) All non-admitted carriers will be required to provide a service of suit endorsement in addition to the additional insured endorsement.
  - (f) In executing this Agreement, CONTRACTOR agrees to have completed insurance documents on file with the CITY within 14 days after the date of execution. Failure to

comply with insurance requirements under this Agreement will be a material breach of this Agreement, resulting in immediate termination at CITY's option.

- 9. This Agreement is subject to California Public Contract Code Section 22300, which permits the substitution of securities for any monies withheld by the City under this Agreement, and permits the CONTRACTOR to have all payments of earned retentions by the City paid to an escrow agent at the expense of the CONTRACTOR.
- 10. Each and every provision of law and clause required by law to be inserted in this Agreement or its attachments shall be deemed to be inserted herein and the Agreement shall be read and enforced as though it were included herein, and if through mistake or otherwise any such provision is not inserted, or is not currently inserted, then upon application of either party the Agreement shall forthwith be physically amended to make such insertion or correction, without further changes to the remainder of the Agreement.
- 11. The complete contract as set forth in Paragraph 1 of this Agreement constitutes the entire Agreement of the parties. No other agreements, oral or written, pertaining to the work to be performed, exists between the parties. This Agreement can be modified only by an amendment in writing, signed by both parties and pursuant to action of the Escondido City Council.

## **Incidents**

## "Swatting" Incident Under Investigation

On January 6, 2019, at approximately 10:08 a.m. Escondido police and fire personnel responded to a false 911 call in the 2000 block of Winamar PI. A caller told 911 dispatchers that there was a house on fire with a woman trapped on the second floor. Reports such as these generate a large emergency response necessary to save human life. However, as emergency personnel arrived it was determined that there was no fire and no emergency. Officers spoke to a teenager at the residence who believed that she was "swatted" after receiving a series of messages on social media. The term "swatting" or "swatted" refers to anonymous callers who call 911 centers falsely reporting significant emergency events that generate a large emergency response. Tragically some of these acts have resulted in injuries and deaths throughout the nation. The Escondido Police department takes these incidents seriously and will seek prosecution for anyone who calls in false reports of an emergency. An investigation into the identity of the caller is on-going.

## **Tricky Thief Thwarted**

On January 11, 2019, at 3:36 p.m. Andrew McCollom (42-year-old resident of Escondido) entered a Verizon store in the 300 block of W. El Norte Pkwy. with what seemed like a clever way to steal a cell phone. As McCollom entered the store he yelled to store employees that someone had just stole his car and that he needed a phone to call 911. McCollom then forcibly removed a cell phone from a display. The employees did not buy his story and quickly tried to prevent the theft. A struggle ensued and McCollom escaped with the stolen phone. Within minutes, officers arrived and arrested McCollom while he was still in the parking lot. McCollom was charged with robbery and booked into the Vista Detention Center.

#### FIRE DEPARTMENT

#### News:

On January 7 at 6:31 p.m., the Escondido Police and Fire Communication Center received a report of a shed on fire near a home at the intersection of 7th Ave. and Spruce St. Upon arrival of the first Engine, the shed was fully involved with fire and it had spread to a nearby large tree. The fire was contained and controlled in approximately 15 minutes, but the shed and contents were a complete loss. In addition, the house sustained minor heat and smoke damage. Public Works crews assisted by falling the large tree. Red Cross also assisted the family with essential

immediate needs. There were no injuries to firefighters or civilians. The cause of the fire is under investigation.

The Escondido Fire Department will hold its annual blood pressure clinics in collaboration with San Diego County Health and Human Services. The event is set for Thursday, February 14 from 9:00 a.m. to 3:00 p.m. at several locations to be announced.

## **Major Projects Update**

The following major projects are being reviewed and coordinated by Planning, Engineering, Fire, Building and Utilities. The list of projects below encompasses recent project updates and/or milestones from last week.

## **Commercial / Office:**

- Escondido Research and Technology Center (ERTC) West (Developer: James McCann) 2181 Citracado Parkway – A plan for a new two-story, 57,000 SF, 52-bed Palomar Rehabilitation Institute was submitted as a Plot Plan on July 31, 2017. The Plot Plan approval letter was issued on February 7, 2018. The grading permit is ready to be issued once Planning confirms information from the applicant that assures adequate parking is provided.
- 2. <u>Escondido Research and Technology Center (ERTC) East (Developer: James McCann) 2130 Citracado Parkway Building plans for the first 71,656 SF medical office building in this approved medical complex area across from Palomar Hospital were submitted into plan check on October 9, 2018. Fire and Esgil have approved the plans. Planning has a hold on the permit until the parking issues below are resolved.</u>
  - A Specific Plan Amendment (SPA) will be required to move the temporary parking lot on this medical building site to another location within ERTC. The SPA application was submitted on November 13, 2018, and proposes the construction of a new temporary parking lot at the southern end of the ERTC development on Lots 10-15 and a permanent parking lot on Lot 1. Fire is requesting paving for all driveways in the proposed temporary parking lot. A comment letter regarding parking counts and storm water requirements was sent to the applicant in mid-December. The applicant provided a draft MOU document on January 4 (intended to be signed by applicant, PPH and City) explaining the phasing and proposed parking improvements. Revised parking lot plans for both the permanent and temporary lots were received on January 8.
- 3. Toyota of Escondido Certified Used Car Facility (Developer: Stephen Myers, Toyota of Escondido) 990 N. Broadway A Plot Plan to assemble five commercial lots including a vacant used car business into an automotive sales and service facility for Toyota. The proposal includes the demolition of a vacant residence and a small expansion of an existing service building. The project application was submitted on January 7. All departments are conducting initial review of the proposal.

## **Industrial**

- 1. Escondido Self-Storage Facility (Developer: Brandywine Homes, Inc.) 2319 Cranston Dr. Updated building plans were resubmitted into plan check on July 24, 2018. Esgil and Fire have approved the plans. Planning provided comments on the building plans on September 19, 2018. The final map was approved by City Council on September 19, 2018, and has recorded. The grading permit has been approved and the final improvement plan mylars have been signed. The building plans have been approved by Esgil and Fire. The Planning approval is still outstanding and awaiting minor plan revisions to be returned by applicant.
- 2. <u>Citracado Business Park (Developer: Dentt Properties) 2207 Harmony Grove Road</u> A proposed specific plan for two industrial warehouse/office buildings (145,930 SF and 125,930 SF) with the buildings to be separated by the future extension of Citracado Parkway. The application was submitted on August 14, 2018. All departments have completed their initial review and comments were sent to the applicant on September 17, 2018. SDG&E also has provided comments regarding the high voltage power lines that traverse the site. The applicant's traffic consultant submitted revised methodology and distribution to Engineering on October 19, 2018. A meeting with the applicant to review the various departmental comments occurred on October 29, 2018. Another round of comments related to the proposed specific plan have also been provided. A revised submittal including the remaining environmental documents is expected soon.

## **City Projects**

- Micro-Filtration Reverse Osmosis (Developer: City of Escondido Utilities Department) SE corner Ash/Washington The City Council approved a contractual agreement with Black and Veatch for engineering services on April 4, 2018. A project design kick-off meeting occurred on June 13, 2018. A Request for Qualifications to solicit a Design/Build firm was released the first week of September. The RFP was issued to a short-list of three selected consultants with a deadline of December 20, 2018, to submit their proposals. On January 16, the City Council discussed the proposed location of the MFRO and provided additional direction to staff.
- 2. <u>Lake Wohlford Replacement Dam (Developer: City of Escondido Utilities Department)</u> A Draft EIR was prepared and issued for a 45-day public review period that began on October 4, 2016 and closed on November 17, 2016. A field visit with staff from the state and federal wildlife agencies took place on May 11, 2017, to review biological mitigation requirements including an agency request for full mitigation for emergent vegetation at the eastern end of the lake that came into existence since the lake level was reduced for safety reasons. Staff sent a follow-up letter to the wildlife agencies on June 29, 2017, seeking clarification on the proposed biological mitigation requirements. Additional information has been compiled and analyzed by the City's biological consultants based on recent conversations with the agencies. The biological consultant and staff met with the wildlife agencies on November 28, 2018 to discuss a modified approach to fulfilling mitigation requirements. Written information summarizing what was discussed at the meeting was transmitted to the agencies on December 4, 2018.

## Institutional

 Escondido Assisted Living (Developer: Tigg Mitchell, Mitchell Group) 1802 N. Centre City Parkway – This CUP application for a 71,300 SF three-story, assisted living and memory care facility with 90 total units was submitted on October 31, 2017. The City Council authorized review of a General Plan Amendment request on March 21, 2018, which was necessary to review the request to allow a third floor for the building. Public review of the draft Mitigated Negative Declaration (MND) commenced on January 11 and closes on February 11. A neighborhood meeting to discuss the project with interested residents has been scheduled for January 30. A Planning Commission hearing has tentatively been scheduled for March 12.

## **Residential**

1. <u>Safari Highlands Ranch (SHR) (Developer: Jeb Hall, Concordia Homes) 550 lots east of Rancho San Pasqual</u> – A Notice of Availability for the Draft EIR was issued on October 16, 2017 for public review and comment. The comment period ended on January 2, 2018. Staff transmitted all the comment letters and emails to the Draft EIR consultant for review and to prepare a response to each comment. The Draft EIR and appendices have been posted on the City's website at the following link:

The responses to comments have generated related revisions to the project design. The applicant's engineer submitted a revised tentative map on October 26, 2018. Generally, the amount of grading and the area of disturbance has decreased, while the overall number of 550 residential lots has remained the same. The revised Tentative Map and exhibits have been posted on-line at the link above.

- 2. 18 lots at 701 San Pasqual Valley Rd (Developer: Bob Stewart) Staff comments on the revised tentative map were issued the last week of July 2017. Planning staff met with the applicant on June 27, 2018 to discuss remaining issues. The applicant has occasionally engaged in discussions with various departments since that time, but has declined a staff offer to schedule a comprehensive meeting with all city departments. Revised plans were submitted the week of November 26, 2018. Fire has noted several previously identified issues remain unaddressed. Planning and Engineering expect to issue comments next week.
- 3. The Villages at Escondido Country Club (Developer: Jason Han, New Urban West, Inc.) 380 residences – The City Council voted 3-2 to approve the project on November 15, 2017. The applicant submitted rough grading plans, drainage improvement plans and utility relocation plans for all three villages on May 7, 2018. There have been three rounds of plan checks on the rough grading plans since the original submittal and a permit-ready letter for rough grading was issued on August 31, 2018 and revised on September 4, 2018. Landscape plans were submitted on June 5, 2018, and a second submittal was received on October 2, 2018. The applicant submitted the final map and other improvement plans on July 9, 2018. Additional comments on the improvement plans, utility location plans, storm drain plans and all technical studies were provided by Engineering on September 11, 2018. Country Club Lane street improvement plans were submitted for first plan check on October 9, 2018, and Engineering comments were provided on November 21, 2018. Second plan check submittal for the Country Club Lane street improvement plans and fourth plan check for the Village 1 rough grading plan are expected to be submitted mid-January. Preliminary floor plans were reviewed and commented on by Planning at the end of December. Architectural plans are expected soon. A tree removal permit to remove trees on the former golf course property was issued by Planning on December 19, 2018.

- 5. North Avenue Estates (Developer: Casey Johnson) 34 lots at North Ave./Conway Dr. –The City Council approved the project on January 10, 2018. LAFCO approved the annexation application on October 1, 2018, and the annexation has recorded. The new homebuilder, Taylor Morrison Homes submitted a Precise Development Plan to Planning on December 14, 2018. Grading plans, final map and improvement plans were submitted for review on December 7, 2018. Staff is still awaiting submittal of a certified Tentative Map as the initial step in the plan check process. It is expected that staff comments will be provided next week.
- 6. Aspire (106 condo units on Municipal Lot 1) (Developer: Addison Garza, Touchstone Communities) The proposal consists of a six-story mixed-use development across from City Hall on Parking Lot 1. The project was initially submitted for entitlement processing on June 23, 2017. Subsequent meetings with the applicant and staff have been on-going, and the most recent resubmittal of the project plans was received on May 10, 2018. Fire is awaiting confirmation that Maple Street will support the weight of their apparatus. A Traffic Impact Analysis has been provided and Planning is awaiting submittal of the rest of the environmental documentation for review. A meeting with the applicant occurred on September 12, 2018, to discuss remaining project issues. A purchase and sale agreement for the project site (Parking Lot 1) was approved by the City Council on September 19, 2018. Concerns regarding parking have been expressed; and the applicant has brought a parking consultant on board to review the issue.
- 7. The Ivy (95 condo units at 343 E. 2nd) (Developer: Addison Garza, Touchstone Communities) The condo project was initially submitted for entitlement processing on June 23, 2017. Subsequent meetings with the applicant and staff have been on-going, and the most recent resubmittal of the project plans was received on May 10, 2018. An environmental initial study and Draft Mitigated Negative Declaration (MND) were submitted for review on June 11, 2018. Comments on the MND were sent to the applicant and consultant on July 30, 2018, and revised documents are expected soon.
- 8. Grand Avenue Apartments (Developer: Norm LaCaze, Escondido Venture 99, LLC) 15 apt. units at 1316 E. Grand Ave. A planned development application proposing 15 multi-family units in one three-story building on a vacant 0.51-acre lot was submitted for entitlement processing on September 22, 2017. Outstanding issues include guest parking, drainage, additional fire hydrant and an ambulance turnaround. A meeting with the applicant to discuss these issues took place on October 11, 2018. Revised plans were resubmitted on November 29, 2018. Planning, Engineering and Fire returned comments in early December.
- 9. Quince Street Senior Housing (Developer: Matt Jumper, 220 Quince, L.P.) 145 apartment units at 220 N. Quince St. The five-story affordable senior housing apartment project was submitted on November 21, 2017. Multiple meetings with the applicant have taken place since the project submittal to discuss project design issues. A constraints map to identify fire access routes and locations of existing utilities has been approved by staff and the applicant utilized that map to submit a revised project on November 21, 2018. Staff comments from Planning, Engineering, Utilities and Fire were returned to the applicant on December 27, 2018. A follow-up meeting with Planning occurred on January 15.

10. Sager Ranch/Daley Ranch Resort Specific Plan (Developer: J. Whalen Associates, Inc., Sager Ranch Partners) 203 housing units and 225-room resort hotel on 1,783-acres, just north and east of Daley Ranch – This proposed residential and resort hotel annexation and specific plan project was received on March 2, 2018. The project submittal has been deemed incomplete and a letter from staff requesting additional project related information was sent to the applicant on April 4, 2018. Requested information includes annexation exhibits, proposed general plan amendment text, a proposed Transfer of Development Rights Program, environmental initial study, and a fiscal impact analysis. Planning met with the applicant on May 17, 2018 to discuss items listed in the letter. A follow-up meeting to discuss engineering issues occurred on June 27, 2018. The applicant met with Escondido Fire and Valley Center Fire on August 1, 2018 to discuss fire protection issues. Significant fire-related issues to be addressed include the steepness of the project entry road, secondary emergency access and Fire Department response times. A follow-up meeting with the applicant to discuss these issues occurred on October 11, 2018.

## Daley Ranch Resort Specific Plan - City of Escondido

- 11. Nutmeg Condo General Plan Amendment (Developer: Jim Simmons, CCI) 137 townhome condo units on 7.7 acres on both sides of Nutmeg between I-15 and Centre City Parkway -This proposed multi-family residential development includes a GPA from Office to Urban III (up to 18 du/acre) as well as a vacation of approximately one acre of public right-of-way for use in the project. The project application was received on June 15, 2018. Comments from Planning, Fire, Engineering, Utilities and Traffic Engineering were provided to the applicant on July 13, 2018. A follow-up meeting with the applicant to discuss the comments occurred on July 31, 2018. Engineering has indicated that a specific alignment plan will be required to address the street radius on Nutmeg along the project frontage. Based on a preliminary environmental study of the project, it has been determined that an Environmental Impact Report will be prepared to support the project. A Notice of Preparation was sent out on August 29, 2018, and closed on October 1, 2018. A Scoping Meeting occurred on September 6, 2018. The applicant submitted revised plans and studies on October 16, 2018. Engineering, Utilities and Fire provided comments on the revised plans on November 13, 2018. A follow-up meeting with the applicant occurred on November 28, 2018. Traffic Engineering provided comments on the Traffic Impact Analysis on December 10, 2018. Staff comments on the first screen check draft of the EIR were issued on January 14.
- 12. Oak Creek (Builder: KB Homes) 65 single-family residential lots on approximately 44 acres at Felicita Road and Hamilton Lane The original developer, New Urban West, has secured permits from CDFW, ACOE and RWQCB. The new builder (KB Homes) filed an application to revise the architecture and reduce the size of the homes. The Zoning Administrator approved a modification to the Precise Development Plan to revise the architecture on October 25, 2018. Grading, drainage and storm water management plans were submitted for first plan check on July 25, 2018. Fire and Engineering issued comments on the rough grading plan on September 4, 2018. Second plan check submittals for rough grading and off-site improvements were received on October 23, 2018 and those plan checks have been completed. Fence and wall plans were submitted the second week of December. The model homes were submitted into plan check the last week of October and still require a Precise

Grading Plan to be submitted. The project biologist and landscape architect are coordinating completion of the biological mitigation requirements with staff prior to issuance of a grading permit. A third plan check of the rough grading plan was received in late December and comments were returned on January 4. Second plan check submittal for the final map and onsite improvements is expected to be received this week. Planning sent comments on the proposed street names last week.

- 13. Mercado 3-Story Mixed Use Building (Developer: Curtis Lively) 5 residences and 2 commercial suites on 0.14-acre at 510 W. 2<sup>nd</sup> Avenue A Plot Plan for five two-story residential units on top of 2,375 SF of commercial floor area and a parking garage was submitted July 13, 2018. Staff review comments were provided to the applicant who then submitted revised plans. Additional Planning and Engineering comments were sent to the applicant on September 27, 2018. Planning provided additional comments on an emailed version of a revised site plan on November 26, 2018, and a revised project submittal was received on December 11, 2018. Comments from Fire, Utilities and Planning on the revised plans were sent to the applicant on January 2. Staff design review was completed on January 3, and comments were provided to the applicant.
- 14. <u>555 West Grand Mixed-Use Building (Developer: Ed McCoy) 32 condo units in three floors over a parking garage</u> This 32-unit mixed-use development with 610 SF of office/flex space was submitted as a planned development application on August 27, 2018. The project is seeking a reduction in parking and open space standards. Initial multi-department comments were sent to the applicant on September 26, 2018. The applicant met with Fire, Engineering, Planning and Utilities staff on October 16, 2018 to discuss the staff comments. An alternative site plan showing garage access from Quince Street was submitted by the applicant on October 31, 2018. A second alternative that provides vehicular access from Second Avenue was discussed with Engineering on December 19, 2018, and a revised site plan incorporating that change of access into the project plans is expected in about two weeks.
- 15. Villa Portofino (Developer: Chris Post, ATC Design Group) 15 apartment units in a three-story building with parking garage at 2690 S. Escondido Blvd. This 15-unit multi-family residential project on a 0.52-acre parcel between S. Escondido Blvd and Cranston Drive was submitted as a Plot Plan application on November 28, 2018. A comment letter was issued on December 20, 2018. Comments included the need to evaluate the building construction type for fire purposes.
- 16. Palomar Heights (Developer: Ninia Hammond, Integral Communities) Demolition and redevelopment of the old Palomar Hospital site with 424 multi-family units in 33 buildings A proposed Tentative Map, Planned Development, Specific Plan Amendment and EIR to redevelop the 13.8-acre former hospital site. Up to 5,500 square feet of recreation or commercial space could be included. The project application was submitted on December 24, 2018. All departments are commencing review of the project plans. The initial plan submittal was presented to the Board of the Downtown Business Association on January 9, and the Economic Development Committee of the Chamber of Commerce on January 10.
- 17. Henry Ranch (Builder: Joe Martin, Trumark Homes) An approved development of 97 single-family residential homes on 74.35 acres at the eastern terminus of Lincoln Avenue The Tract 920 development proposal was originally approved in 2007 and an extension of the associated Development Agreement was approved in 2016. Trumark Homes acquired the property in 2018 and intends to complete the subdivision. A revised substantial conformance plan for the

- Certified Tentative Map was submitted January 15. Submittal of final engineering plans is expected soon.
- 18. <u>Accessory Dwelling Units</u> Planning staff is currently working on five applications for accessory dwelling units. No accessory dwelling units have been approved yet this year. 24 accessory dwelling units were approved in 2018. Three accessory dwelling units were approved in 2017.

## **Building Division:**

- 1. The Building Division issued 58 permits (including 23 solar photovoltaic) with a total valuation of \$1,913,803.
- 2. Our building inspectors responded to 167 inspection requests and 159 customers visited the Building counter during the week.
- 3. No change from the previous: The Meadowbrook three-story apartment building with underground garage at 2081 Garden Valley Glen is preparing the building for final inspection. Building inspected the suspended ceiling on January 4.
- 4. No Change from the previous: The Westminster Seminary at 1725 Bear Valley Pkwy so far has received final inspection approval and Temporary Certificates of Occupancy for all buildings except for Buildings B and H.
- 5. No change from the previous: The Emmanuel Faith Church at 639 E. 17<sup>th</sup> Ave received final inspection corrections on November 14, 2018 and they are working on the inspection corrections.
- 6. *No change from the previous:* The Veterans Village project at 1540 S Escondido Blvd has received approval for early gas meter release for testing.
- 7. The Latitude 2 apartment project at 650 Center City Pkwy has received a 30-day Temporary Certificate of Occupancy for Building 1, drywall inspection at Building 6, trash enclosure foundation inspection at Building 3 and electric meter release at Building 4.
- 8. *No change from the previous:* The new two story church sanctuary building at 1864 N. Broadway has completed exterior lath and drywall.
- 9. The Citron multi-family project at 2516 S. Escondido Blvd. has received rough framing approval for Buildings 7 and 8, exterior lath for Building 9, electric meter release for Building 4, gas test for Building 5 and drywall for Building 10.
- 10. No change from the previous: The new 105-room hotel at 200 La Terraza received drywall approval for the 4th floor corridors.
- 11. The four-story, 102,774 sf self-storage building at 222 W. Mission Ave has received inspection approval for drywall throughout the building.

- 12. The new five-story self-storage building at 852 Metcalf St. has received 3th floor pan deck framing inspection.
- 13. No change from the previous: The new Gateway Grand 126-unit apartment project at 700 W. Grand Ave. has received foundation for all pier footings for Building A and foundation and slab inspection for Buildings A and B and the clubhouse building and grade beams for Building C.
- 14. No change from the previous: Inspections have been requested for floor sheathing for all 3 buildings at the new apartments on 917 W. Lincoln Ave. The project has 3 buildings and 9 total units.
- 15. Permits were issued for a new 4,668 square foot single story bank building with drive-thru at 150 N. Quince.
- 16. Permits were issued for structural repairs at the former Baja Foods building at 607 W. 9<sup>th</sup> Ave.
- 17. Permits were issued for two new single-family dwellings at 829 E 4<sup>th</sup> Ave.

## **Capital Improvements**

- Valley Parkway/Valley Center Road Widening Project: Calendar Day 373 The contractor is applying organic mulch to sloped surfaces that were disturbed or constructed during the course of construction. The electrical meter that supplies power to the irrigation controller for the southerly section of the project is set to be installed on Thursday of this week.
- 2. <u>Transit Center Pedestrian Bridge Project</u> *No changes from that reported last week:* Transit Center Pedestrian Bridge and Spruce Street Channel Improvement Project is moving forward with 100% design. The project is currently out to bid. In response to several requests by prospective bidders, the bid opening date was extended to January 24.
- 3. <u>Missing Link Project</u> –Engineering staff has reached out to the manufacturer of the traffic signal poles for the Woodward/Broadway intersection. They informed the City on Wednesday January 16 that the new shipping date will now be May 3. No clear explanation has been provided to explain the discrepancy for information previously provided.
- 4. <u>HSIP Traffic Signal Project</u> *No changes from that reported last week*: The project will provide new traffic signals at Valley Parkway/Date Street and El Norte Parkway/Fig Street intersections. The project is funded by the Highway Safety Improvements Projects. The Notice to Proceed was issued this week during a preconstruction meeting. The traffic signal poles will be ordered this week with an anticipated delivery in 20 weeks. The construction of the surface improvements will begin on May 6.

- 5. <u>Tulip Street Improvements Phase IV</u> The Tulip Street Phase IV bid opening was held. The apparent low bidder is Southland Paving Inc. with a bid of \$1,148,793.75. The project will complete Tulip Street between 2<sup>nd</sup> and 3<sup>rd</sup> Street as well as a portion of Grand Avenue. The project will be awarded at Wednesday's City Council meeting.
- 6. <u>Multi Neighborhood Street Light L.E.D. Retrofit Project</u> The project will upgrade 644 existing high pressure sodium lights with energy efficient L.E.D. fixtures. The project boundaries are Lincoln Avenue to the North, 13<sup>th</sup> Avenue to the South, Ash Street to the East and Upas Street to the West. The project will be awarded at Wednesday's City Council meeting.
- 7. Storm Drain Pipe Lining and Rehabilitation Project Phase1 The project consists of 14 work zones and 3 Bid Alternate locations for the videoing, grouting, repairing, and lining of existing corrugated metal pipes (CMP) within the Cities inventory. The project bid opening was January 10. Four Engineering contractors supplied bids. The apparent low bidder was Sancon Engineering Inc. with a bid of \$841,310.00. The Engineers estimated the project will cost \$746,734.00

## **Private Development**

- 8. <u>Centre City Shopping Center</u> The project has been walked and a punch list has been provided. The traffic signal contractor has been on site working to resolve signal reliability issues. The project is located at 425 West Mission Avenue.
- 9. <u>Tract 932 Canyon Grove Shea Homes Community No changes from that reported last week:</u> Engineering will be finagling additional houses this week. Of the 179 home lots developed since the start of construction on February 11, 2016, only 30 remain unoccupied.
- 10. <u>Latitude II Condominiums by a Lyon Homes Partnership: Washington Avenue @ Centre City Parkway</u> *No changes from that reported last week:* The contractor is removing excess soil material from along the Centre City Parkway frontage this week.
- 11. <u>Exeter Industrial Park</u> –*No changes from that reported last week*: The new pedestrian ramp and traffic signal relocation were completed this past week as scheduled. Project completion is expected in the coming weeks. The project is located at 2005 Harmony Grove Road.
- 12. <u>Tract 934</u> Is a 5 lot subdivision located at 1207 Gamble Street. The construction of the underground utilities is scheduled to begin soon.
- 13. <u>Gateway Project</u> The contractor has completed final water quality testing. Due to the weather conditions final water line connections have been delayed to the following week. The project is located at 700 W. Grand Avenue, the previous site of Escondido Police Department.
- 14. <u>Lincoln Rock Apartments</u> –*No changes from that reported last week*: On site paving has been performed and delivery of lumber to the site has begun. The project is located at the Southwest corner of Rock Springs Road and Lincoln Avenue.
- 15. <u>Veterans Village</u> The construction of onsite improvements is the focus of construction this week.

16. <u>KB Homes Oak Creek Project</u> - *No changes from that reported last week*: The contractor is nearing completion of the remedial grading to remove unsuitable material from within the project. This is work is focused on 4 specific areas. The project is located at the intersection of Hamilton Lane and Miller Avenue.
