CITY OF ESCONDIDO, a Municipal corporation, (Grantor), grants to SAN DIEGO GAS & ELECTRIC COMPANY, a corporation (Grantee), an easement and right of way in, upon, over, under and across the lands hereinafter described, to erect, construct, change the size of, improve, reconstruct, relocate, repair, maintain and use facilities consisting of:

The easement in the aforesaid lands shall be 12.00 feet in width, being 6.00 feet on each side of the center line of the facilities to be installed, the approximate location being shown and delineated as "UTILITY FACILITIES" on the Exhibit "A", attached hereto and made a part hereof.

Grantor grants to Grantee the right to erect and maintain on Grantor's property adjacent to this easement such anchorage as may be necessary for Grantee's purposes.

Grantor shall not erect, place or construct, nor permit to be erected, placed or constructed, any building or other structure, plant any tree, drill or dig any well, within this easement.

Grantor shall not increase or decrease the ground surface elevations within this easement after installation of Grantee's facilities, without prior written consent of Grantee, which consent shall not unreasonably be withheld.

Grantee shall have the right but not the duty, to trim or remove trees and brush along or adjacent to this easement and remove roots from within this easement whenever Grantee deems it necessary. Said right shall not relieve Grantor of the duty as owner to trim or remove trees and brush to prevent danger or hazard to property or persons.

The legal description for this easement was prepared by San Diego Gas & Electric Company pursuant to Section 8730 of the Business and Professions Code, State of California.





#### **RECOMMENDATION:**

The Utilities Department requests that the City Council Adopt Resolution No. 2015-83 authorizing the Mayor and City Clerk to execute a Consulting Agreement for \$477,280 with Michael Baker International for construction management services.

#### FISCAL ANALYSIS:

Wastewater CIP 801201, Recycled Water Easterly Main Extension has sufficient funds to cover this expenditure.

#### PREVIOUS ACTION:

On September 24, 2014, the Council adopted Resolution No. 2014-145 awarding a Public Improvement Agreement to MNR Construction, Inc., for the construction of the initial phase of the Recycled Water Easterly Main Extension.

On December 12, 2014, the City Utilities Construction Manager issued a Notice to Proceed to MNR Construction, Inc.

#### **BACKGROUND:**

The Recycled Water Easterly Main Extension project will install two pipelines along the northern side of Escondido Creek between N. Broadway and Citrus Avenue:

- 13,800-LF of 16" High-density Polyethylene (HDPE) brine gravity pipeline
- 13,783-LF of 28" HDPE recycled water pressure pipeline

This project is the first component of the Recycled Water and Potable Reuse Program, which will deliver recycled water to agricultural land in the eastern portion of the City's water service area. When construction was awarded in September 2014, Utilities staff intended to provide construction management services in-house. Since that time, however, Utilities Department management decided that it would be more efficient to award construction management to outside consultants. This decision is based on two primary factors: (1) staffing limitations that make it infeasible for the work to be done in-house while still managing other Utilities construction projects, and (2) additional project complexity caused by permitting, underground conflicts, and delays approving material substitutions.

The rapid growth of the CIP managed by the Utilities Engineering and Construction Management Division has exceeded the capacity of existing staff. The Division's Deputy Director supervises three engineers and four construction management staff. As work load has increased Utilities management considered requesting more staff to manage projects as they moved from design into construction. However, the work load is expected to vary greatly over the next three years. Therefore, it is most efficient to award the work to consultants who can be retained as needed and only when needed.

The Utilities Department recommends retaining Michael Baker International, a third party construction management team, to manage the remainder of project construction for this project. This contract for construction management services includes constructability reviews, construction inspections, administration of the construction contract, claim support, and facilitation of partnering sessions.

WHEREAS, on December 12, 2014, the City Utilities Construction Manager issued a Notice to Proceed to MNR Construction, Inc.; and

WHEREAS, the Utilities Engineering Division is currently managing the design and construction for multiple large Capital Improvement Program ("CIP") projects; and

WHEREAS, at this time the Director of Utilities, deeming it to be in the best public interest, requests the City Council to execute a Consulting Agreement to provide third-party construction management services.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California, as follows:

- A. It has been determined to be in the CITY's best interest to retain the professional services of a consultant to provide construction management and inspection services for the Recycled Water Easterly Main Extension project; and
- B. The CONSULTANT is considered competent to perform the necessary professional services for CITY;

NOW, THEREFORE, it is mutually agreed by and between CITY and CONSULTANT as follows:

- 1. <u>Services</u>. The CONSULTANT will furnish all of the services as described in "Attachment A" which is attached and incorporated by this reference.
- 2. <u>Compensation</u>. The CITY will pay the CONSULTANT in accordance with the conditions specified in "Attachment A," in the sum of \$ 477,280.00. Any breach of this Agreement will relieve CITY from the obligation to pay CONSULTANT, if CONSULTANT has not corrected the breach after CITY provides notice and a reasonable time to correct it. If this Agreement is amended at any time, additional compensation of CONSULTANT contained in subsequent amendment(s) shall not exceed a cumulative total of twenty-five percent (25%) of the maximum payment provided for in this Section 2.

- 3. <u>Scope of Compensation</u>. The CONSULTANT will be compensated for performance of tasks specified in "Attachment A" only. No compensation will be provided for any other tasks without specific prior written consent from the CITY.
- 4. <u>Duties.</u> CONSULTANT will be responsible for the professional quality, technical accuracy, timely completion, and coordination of all reports and other services furnished by the CONSULTANT under this Agreement, except that the CONSULTANT will not be responsible for the accuracy of information supplied by the CITY.
- 5. Personnel. The performance of services under this Agreement by certain professionals is significant to the CITY. CONSULTANT will assign the persons listed on "Attachment B," which is attached and incorporated by this reference, to perform the Services described in Paragraph 1, and will not add or remove persons from the list without the prior written consent of the CITY. If no designation is made, then CONSULTANT may not assign services without obtaining the advance written consent of the CITY. CONSULTANT will not subcontract any tasks under this Agreement without obtaining the advance written consent of the CITY.
- 6. <u>Termination</u>. Either CONSULTANT or the CITY may terminate this Agreement with thirty (30) days advance written notice.
- 7. <u>City Property</u>. All original documents, drawings, electronic media, and other material prepared by CONSULTANT under this Agreement immediately becomes the exclusive property of the CITY, and may not be used by CONSULTANT for any other purpose without prior written consent of the CITY.
- 8. Insurance.
  - a. The CONSULTANT shall secure and maintain at its own cost, for all operations, the following insurance coverage, unless reduced by the City Attorney:
    - (1) General liability insurance. Occurrence basis with minimum limits of \$1,000,000 each occurrence, \$2,000,000 General Aggregate, and \$1,000,000 Products/Completed Operations Aggregate; and
    - (2) Automobile liability insurance of \$1,000,000 combined single-limit per accident for bodily injury and property damage, unless waived as provided in 8(b) below; and
    - (3) Workers' compensation and employer's liability insurance as required by the California Labor Code, as amended, or certificate of sole proprietorship; and
    - (4) Errors and Omissions professional liability insurance with minimum coverage of \$1,000,000.
  - b. It is the parties' understanding that the use of a motor vehicle is not a primary subject of this Agreement. CONSULTANT acknowledges that operating a motor vehicle is outside the scope of this Agreement and occurs only at the convenience of the CONSULTANT. A waiver of automobile liability insurance is only effective if both sets of initials appear below, otherwise such insurance is required.

- Each insurance policy required above must be acceptable to the City Attorney.
  - (1) Each policy must provide for written notice within no more than thirty (30) days if cancellation or termination of the policy occurs. Insurance coverage must be provided by an A.M. Best's A- rated, class V carrier or better, admitted in California, or if non-admitted, a company that is not on the Department of Insurance list of unacceptable carriers.
  - (2) All non-admitted carriers will be required to provide a service of suit endorsement in addition to the additional insured endorsement.
  - (3) Both the General Liability and the Automobile Liability policies must name the CITY specifically as an additional insured under the policy on a separate endorsement page. The CITY includes its officials, employees, and volunteers. The endorsement must be ISO Form CG 20 10 11 85 edition or its equivalent for General Liability endorsements and CA 20 01 for Automobile Liability endorsements.
  - (4) The General Liability policy must include coverage for bodily injury and property damage arising from CONSULTANT's work, including its on-going operations and products-completed operations hazard.
  - (5) The General Liability policy must be primary and noncontributory and any insurance maintained by CITY is excess.

Failure to comply with insurance requirements under this Agreement will be a material breach of this Agreement, resulting in immediate termination at CITY's option.
- 9. <u>Indemnification</u>. CONSULTANT (which in this paragraph 9 includes its agents, employees and subcontractors, if any) agrees to indemnify, defend, and hold harmless the CITY from all claims, lawsuits, damages, judgments, loss, liability, or expenses, including attorneys' fees, for any of the following:
  - a. Any claim of liability arising out of the negligence or any acts or omissions of CONSULTANT in the performance of this Agreement;
  - b. Any personal injuries, property damage or death that CONSULTANT may sustain while using CITY-controlled property or equipment, while participating in any activity sponsored by the CITY, or from any dangerous condition of property; or
  - c. Any injury or death which results or increases by any action taken to medically treat CONSULTANT.
- 10. Anti-Assignment Clause. The CONSULTANT may not assign, delegate or transfer any interest or duty under this Agreement without advance written approval of the CITY, and any attempt to do so will immediately render this entire Agreement null and void. Unless CONSULTANT assigns this entire Agreement, including all rights and duties herein, to a third party with the CITY'S written consent, CONSULTANT shall be the sole payee under this Agreement. Any and all payments made pursuant to the terms of this Agreement are otherwise not assignable.
- 11. <u>Costs and Attorney's Fees</u>. In the event that legal action is required to enforce the terms and conditions of this Agreement, the prevailing party will be entitled to reasonable attorneys' fees and costs.

- 12. <u>Independent Contractor</u>. CONSULTANT is an independent contractor and no agency or employment relationship, either express or implied, is created by the execution of this Agreement.
- 13. <u>Merger Clause</u>. This Agreement and its Attachments, if any, are the entire understanding of the parties, and there are no other terms or conditions, written or oral, controlling this matter. In the event of any conflict between the provisions of this Agreement and any of its Attachments, the provisions of this Agreement must prevail.
- 14. <u>Anti-Waiver Clause</u>. None of the provisions in this Agreement will be waived by CITY because of previous failure to insist upon strict performance, nor will any provision be waived by CITY because any other provision has been waived, in whole or in part.
- 15. <u>Severability</u>. The invalidity in whole or in part of any provision of this Agreement will not void or affect the validity of any other provisions of this Agreement.
- 16. <u>Choice of Law.</u> This Agreement is governed by the laws of the State of California. Venue for all actions arising from this Agreement must be exclusively in the state or federal courts located in San Diego County, California.
- 17. <u>Multiple Copies of Agreement/Counterparts</u>. Multiple copies and/or counterparts of this Agreement may be executed, including duplication by photocopy or by computerized scanning device. Each duplicate will be deemed an original with the same effect as if all the signatures were on the same instrument. However, the parties agree that the Agreement on file in the office of the Escondido City Clerk is the copy of the Agreement that shall take precedence should any differences exist among copies or counterparts of the document.
- 18. <u>Provisions Cumulative</u>. The foregoing provisions are cumulative and in addition to and not in limitation of any other rights or remedies available to the CITY.
- 19. <u>Notices to Parties</u>. Any statements, communications or notices to be provided pursuant to this Agreement must be sent to the attention of the persons indicated below. Each party agrees to promptly send notice of any changes of this information to the other party, at the address first above written.
- 20. <u>Business License</u>. The CONSULTANT is required to obtain a City of Escondido Business License prior to execution of this Agreement.
- 21. Compliance with Applicable Laws, Permits and Licenses. CONSULTANT shall keep itself informed of and comply with all applicable federal, state, and local laws, statutes, codes, ordinances, regulations, and rules in effect during the term of this Agreement. CONSULTANT shall obtain any and all licenses, permits, and authorizations necessary to perform services set forth in this Agreement. Neither CITY, nor any elected nor appointed boards, officers, officials, employees, or agents of CITY shall be liable, at law or in equity, as a result of any failure of CONSULTANT to comply with this section.
- 22. <u>Immigration Reform and Control Act of 1986</u>. CONSULTANT shall keep itself informed of and comply with the Immigration Reform and Control Act of 1986. CONSULTANT affirms that as an employer in the State of California, all new employees must produce proof of eligibility to work in the United States within the first three days of employment and that only employees legally eligible to work in the United States will be employed on

this public project. CONSULTANT agrees to comply with such provisions before commencing and continuously throughout the performance of this Agreement.

#### **SCOPE OF SERVICES**

#### **PROJECT DESCRIPTION**

The WORK of this Contract comprises but is not limited to the construction of approximately 13,780 lineal feet of 28-inch diameter DR 11 high density polyethylene (HDPE) recycled water pipeline, and 13,800 lineal feet of 16-inch diameter DR 21 HDPE brine pipeline, asphalt concrete (AC) pavement, steel casing pipes, concrete manholes, recycled water isolation valves, air valves, blow-offs, connections to existing facilities, protection of existing facilities, surface restoration, and other pipeline appurtenances and related work.

#### **ORDINANCE NO. 2015-12**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ESCONDIDO, CALIFORNIA, AMENDING ARTICLE 5 OF CHAPTER 31 OF THE ESCONDIDO MUNICIPAL CODE TO ADD RECENT STATE REQUIREMENTS FOR WATER CONSERVATION

The City Council of the City of Escondido, California, DOES HEREBY ORDAIN as follows:

SECTION 1. Article 5, Section 31-227 of Chapter 31 of the Escondido Municipal Code is hereby amended to read as follow:

#### Sec. 31-227. Definitions.

The following words and phrases whenever used in this chapter shall have the meaning defined in this section.

- (a) "Baseline period" means the period of time during which a customer's water use in prior years shall be used to compare to the same customers water use during a declared water shortage. The baseline period will be determined by the City Council at the time the City Council declares the appropriate water shortage response level, as outlined in section 31-232 of this article.
  - (b) "City" means the City of Escondido.
- (c) "Customer" means any natural person, corporation, public or private entity, public or private association, public or private agency, government agency or institution, school district, college, or any other user of water provided by the City.

#### **RECOMMENDATION:**

It is requested that Council adopt Resolution No. 2015-84 approving the Fiscal Year 2015/16 Annual Operating Budget. It is also requested that the Council adopt Resolution No. 2015-85 approving the Appropriations Limit (Gann Limit) for FY 2015/16.

#### FISCAL ANALYSIS:

A two-year General Fund budget has been submitted with the assumption that the City will continue to show economic growth. The proposed FY 2015/16 General Fund Operating Budget is a balanced budget without the use of reserves and projects a 5% increase in total revenues. See Attachment A for the General Fund Three Year Financial Plan through FY 2019.

#### BACKGROUND:

Since the operating budget briefing on May 6, 2015, the General Fund Operating Budget has decreased by approximately \$50,000. This is primarily due to a reorganization of staff within the City Attorney's Department, which included a reclassification of a regular part-time position to a regular full-time position. The current General Fund reserve balance is \$17.3 million.

The Community Services department has further reduced their operating budget by approximately \$276,000 and is proposing to use \$94,000 of Community Services fund reserves to balance their sources and uses of funds. This results in the General Fund transfer remaining at \$223,100.

SUBJECT:

Limiting Landscape Irrigation with Potable Water to Two Days Each Week

#### **RECOMMENDATION:**

The Utilities Department requests that Council adopt Resolution No. 2015-98 declaring that landscape irrigation with potable water within the water service area of the City of Escondido shall be limited to two days each week for no more than 10 minutes at each irrigation station. Specific information about the watering days assigned to each customer is provided later in this report.

#### FISCAL ANALYSIS:

No additional funds will be necessary to support this resolution. Restrictions on irrigation will reduce water sales as required by California's emergency drought regulations in effect since May 18, 2015. Reduced water sales will reduce Water Fund revenue, but this reduction in revenue will be largely offset by reductions in imported water cost and operating cost.

#### PREVIOUS ACTION:

Consideration of this resolution is contingent on Council approval of amendments to the Escondido Municipal Code (EMC) so that Chapter 31-232 Part (b)(3)(A) specifies that "irrigating landscape with potable water shall be limited in frequency as determined necessary by the City Council by resolution." If the City Council does not approve the proposed amendment, Resolution No. 2015-98 will not be considered by the Council on June 10, 2015.

The City Council declared a Drought Response Level 2 on August 14, 2014. This declaration limited landscape irrigation with potable water within the water service area of the City of Escondido to three days each week for 10 minutes at each irrigation station. This proposed resolution would further reduce watering days from three to two each week.

#### BACKGROUND:

On May 14, 2015, the San Diego County Water Authority (SDCWA) Board of Directors adopted an ordinance that specified restrictions on water deliveries to its member agencies. This ordinance was

passed in response to California's emergency drought regulations which included unprecedented mandates for retail water deliveries, and in response to the Metropolitan Water District's allocation of 15% less water to the SDCWA.

Among the provisions of the SDCWA ordinance is a requirement that all member agencies restrict outdoor landscape irrigation using potable water to two days per week. Adopting Resolution No. 2015-98 will comply with the requirement of that SDCWA ordinance and help the City meet its 20% water delivery reduction mandated by the State.

The proposed landscape irrigation schedule is detailed below.

- Homes with odd-numbered addresses may water outdoor landscapes on Sunday and Thursday. Homes with even-numbered addresses may water Tuesday and Saturday.
- Apartments, condos, and businesses may water outdoor landscape on Monday and Friday.
- Watering time is limited to 10 minutes per irrigation station (e.g., per irrigation zone) and watering is not allowed between the hours of 10:00 AM and 6:00 PM.
  - Certain exceptions are noted in the Escondido Municipal Code.

Council adoption of Resolution 2015-98 does not change the current Drought Response Level. The City of Escondido remains at Drought Response Level 2.

#### RESOLUTION NO. 2015-98

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ESCONDIDO, CALIFORNIA, LIMITING LANDSCAPE IRRIGATION TO TWO DAYS PER WEEK

WHEREAS, the City Council previously adopted Escondido Municipal Code Chapter 31, Article 5, Section 31-232 in 2008 authorizing the City Council to declare Water Alert Conditions in response to water shortages within Southern California by duly adopted resolution; and

WHEREAS, since that time, basic conservation measures have been in force at all times that help to preserve water – a precious resource; and

WHEREAS, the State Water Resources Control Board has approved emergency regulations to ensure agencies increase their water conservation efforts in response to California's drought emergency; and

WHEREAS, the City Council declared a "Water Shortage Response Level Two – Water Shortage Alert Condition" on August 13, 2014, in an effort to meet the requirements of the emergency regulations by reducing outdoor water use with the imposition of specific days and maximum duration for the watering of landscape; and

WHEREAS, California continues to suffer from drought conditions statewide; and

WHEREAS, the San Diego County Water Authority on May 14, 2015, approved an ordinance requiring its member agencies, including the City of Escondido, to limit outdoor irrigation to two days per week.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California:

1. That the above recitations are true.

- 2. That the City Council hereby limits outdoor watering of landscapes to two days per week pursuant to Escondido Municipal Code Section 31-232. Homes with odd-numbered addresses may water outdoor landscapes on Sunday and Thursday. Homes with even-numbered addresses may water Tuesday and Saturday. Homes are not to water more than 10 minutes per watering station. Apartments, condos, and businesses may water landscapes not more than 10 minutes per watering station on Monday and Friday. Watering stations are also known as zones controlled by an irrigation system.
- 3. This limitation on outdoor watering of landscapes will become effective upon the effective date of Ordinance No. 2015-12.

#### **ECONOMIC DEVELOPMENT**

The Economic Development Division, in partnership with the Utilities Department, is offering a special informational meeting for businesses about how the new drought regulations may affect them. The meeting will be held on June 23 from 6:00 to 7:00 p.m. in the Mitchell room. Christopher McKinney, Director of Utilities will give an update on the new regulations as well as tips for businesses from the water conservation staff. All business owners are welcome to attend.

#### **UPDATE ON REFUNDING BOND ISSUES**

On April 22, 2015, Council approved resolutions 2015-59, 60, and 61, authorizing the issuance of three Refunding Bond issues for the purpose of achieving future debt service cost savings from the refinancing of three existing bond obligations. As of May 12, all three Refunding issues have been successfully sold and are in various stages of finalization. All three Refunding Bond issues will be finalized and closed before fiscal year end and the related outstanding refunded bond issues will be fully redeemed on or before September 1, 2015. Economic and market conditions existing on the date of each respective bond sale proved favorable to the City. For each of the Refunding Bond issues, the final realized present value savings exceeded the original savings estimates presented to Council. The City will realize \$12.6 Million in aggregate net present value savings for the three refunding transactions, which represents an increase of \$1.7 million, or 15.6 %, over the original estimate of \$10.9 million (based on March 6, 2015 market conditions and assumptions). The effect of the savings realized on these refunding transactions translates to: (1) average annual cash flow savings of \$746,000 related to reduction of Wastewater Utility Fund debt service costs; (2) General Obligation Bond debt service cash flow savings averaging \$488,000 per year, and resulting in an estimated 10 percent decrease in the 2015-16 General Obligation tax levy rate as applied to assessed property values; and (3) a decrease in annual debt service costs related to the Eureka Ranch CFD bonds, resulting in average annual cash flow savings of \$151,000 and producing an average annual tax levy savings of approximately \$400 per parcel for residents in the Eureka Ranch Community Facilities District.

#### **COMMUNITY DEVELOPMENT**

#### Planning:



- Felicita Development, LLC has submitted a Planned Development application for the vacant 6.9 acre property at the southeast corner of Felicita Rd. and Gamble Lane. The proposed project includes the phased development of a 140-unit hotel, an 80-unit extended stay hotel, a 120-bed assisted living facility and a gas station. The application is under review for completeness.
- Interfaith has submitted a Conditional Use Permit application for a 50-bed year-round emergency shelter at their existing facility at 550 W. Washington. The CUP application is under review for completeness.
- Staff continues to monitor major development applications that are currently being processed to assess their entitlement status in light of pending and more restrictive storm water requirements that the Regional Water Quality Control Board (RWQCB) requires be adopted by the City on or before December 24, 2015. Staff anticipates a heavy workflow from developers who have expressed an interest in starting grading of their projects prior to December 24th in order to be subject to current requirements. Staff is taking a proactive approach to discuss processing timelines with existing applicants and providing guidance to applicants on what they can do to meet their desired goals. The final RWQCB workshop on "prior lawful approval" (to define what projects can proceed under the existing permit) is on June 30th. The draft language is anticipated to be released a few days beforehand, and the language still needs to go through the adoption process. The main public portal is www.projectcleanwater.org.
- The tentative subdivision map application submitted for the former Escondido Country Club property is undergoing a review for completeness. Comments will be issued to the applicant by June 5th. Until the litigation is resolved and the City decides not to appeal, the ECCHO initiative remains in effect and would prevent a residential project from being processed. The proposed project description and additional information is available at the following link:

- The County of San Diego has released the Draft Environmental Impact Report (DEIR) for the proposed Valiano Specific Plan project in Eden Valley. Comments from agencies, organizations, and interested individuals are due to the County on June 15, 2015. The proposed project includes 326 homes on 238 acres. The San Dieguito Community Planning Group will be considering the Valiano project at a separate meeting, tentatively scheduled for June 11, 2015. #### Major Projects Update:

 Oak Creek (NUW) – The applicant is preparing additional information requested by LAFCO for the annexation application. The applicant is coordinating with LAFCO



staff regarding their recommendation that the proposed annexation boundary be expanded to include a roadway segment of Hamilton Lane between Bernardo and Felicita Avenues. This road segment does not meet City standards. A LAFCO hearing date has not yet been scheduled. Staff met to with the developer to discuss the permit submittal and plan check process, particularly regarding their timing expectations in anticipation of the new storm water requirements.

- <u>Amanda Estates (NUW)</u> LAFCO staff has reviewed the two annexation applications for completeness and sent a letter identifying the additional information needed to process the Amanda Estates annexation and the associated annexation for the "Disadvantaged Unincorporated Community" (DUC) properties. No further action is anticipated for the DUC annexation. A LAFCO hearing date has not yet been scheduled.
- Centerpointe 78 Commercial Staff is reviewing sections of the screen check EIR as they become available. An amendment to the EIR contract was approved on May 20<sup>th</sup>, to authorize additional traffic analysis of the alternative traffic mitigation measures proposed by the applicant. Funding for this amendment has been requested but not yet received. The consultant is awaiting submittals from the applicant needed to complete the draft EIR.
- North Broadway Deficiency Area Projects Staff continues to coordinate with the various development teams regarding the design of infrastructure improvements and has taken a proactive approach with County staff on review of required improvements within the unincorporated area. A grading permit has been issued for Lennar's "Pradera" project and building permit applications for the model homes (incorporating enhanced architectural features) are anticipated in the next week. Staff is working with the applicant to resolve setback issues relating to the location of the perimeter walls. The <u>Pickering</u> annexation has been recorded. The <u>Zenner</u> annexation application is under review by LAFCO.
- Kaen Planned Development (2516 S. Escondido Blvd.) –The applicant is evaluating a redesign that would eliminate up to 3 units to provide improved emergency access, neighborhood compatibility and aesthetics. The application remains incomplete.
- <u>Wohlford</u> A letter has been sent for the proposed 55-unit residential subdivision and planned development at 661 Bear Valley Parkway advising the applicant that the application is incomplete and identifying the necessary submittals to continue processing the application. The applicant is coordinating with staff regarding a Specific Alignment Plan for Bear Valley Parkway and is exploring acquisition of the adjacent, triangular shaped parcel to the south to accommodate anticipated road improvements along this road. Resubmittal is anticipated in the next week.
- Latitude II Staff continues to work with the applicant's design team to identify and evaluate solutions on site planning issues. A revised Fire Master Plan has been submitted for review. The applicant continues to negotiate with the owner of the adjacent motel regarding the use of the remnant parcel containing the motel sign along CCP. Consensus has not yet been reached regarding the design of the sewer line easements and improvements along the east property line. Preparation of a



traffic study and draft negative declaration by the applicant's consultant is underway, but has not yet been submitted.

- Staff has provided comments on the revised tentative map submitted by <u>Shea Homes</u> for a substantial conformance review and determination for the 179-lot residential subdivision known as <u>Hidden Valley Ranch (Tract 923)</u>. A revised plan for the internal park acreage is under review. While the Precise Plan has not yet been submitted, the applicant has identified up to 20 lots where the proposed units do not meet setback requirements of the planned development.
- The proposed modification to redevelop the Emmanuel Faith Community Church campus at 639 E. 17<sup>th</sup> Ave. is scheduled for Planning Commission on June 9<sup>th</sup>. Information on the project can be found at: <a href="https://www.escondido.org/emmanuel-faith-community-church.aspx">www.escondido.org/emmanuel-faith-community-church.aspx</a>
- Concordia Homes submitted a draft Specific Plan and tentative subdivision map for the <u>Safari Highlands</u> project for conceptual review prior to their formal application submittal. The project includes annexation and Sphere of Influence update for the 1,098 acres site and a subdivision to create 550 residential lots in seven neighborhoods, with lot sizes ranging from 7,663 SF to 4.76 acres. Staff working on consultant agreements to provide extension of staff services to process the anticipated application; execution of the contracts is needed prior to submittal of a formal application. The applicant is coordinating with LAFCO regarding anticipated requirements and study area for a Sphere of Influence update.

#### **Building Division:**

- The Building Division issued 69 permits for the week with a total valuation of \$352,582.
- 27 photovoltaic permits were issued for the week. Building has issued 438 permits so far this year compared to 215 issued at the same time last year.
- Inspections and counter contacts remain steady with inspections averaging 31 per day with 25 on Friday and counter contacts averaging 35 per day with 19 on Friday.
- The <u>Department of Housing and Community Development HCD</u>), Division of Codes and Standards has issued an Information Bulletin (attached) regarding Emergency Regulations which were approved by the Building Standards Commission on May 29, 2015, and are effective June 1, 2015. These emergency regulations are intended to reduce outdoor potable water irrigation for newly installed landscapes for new residential construction by requiring water budgets with modified adjustment factors.

#### **Code Enforcement:**

• As of June 1<sup>st</sup>, the total number of open code enforcement case is 386 cases, with a backlog of an additional 58 cases not yet opened for assignment and investigation.



During the prior week, 39 new cases were opened, 64 cases were closed and a total of 98 signs were removed. While no public records requests (PRR) were processed last week, the year-to-date total is 60 requests. Recruitment is underway for one full-time and three part-time vacant officer positions to assist with the backlog.

• Last week the Business License Division received 22 new applications and 148 renewals, and issued 10 new licenses.

#### **CAPITAL IMPROVEMENTS**

#### FY 2014-2015 Street Rehabilitation Project:

June 1, 2015 through June 5, 2015 the concrete subcontractor will be completing concrete for the pedestrian ramps, driveways and sidewalks along Grand Avenue, Hickory Street to Valley Boulevard.

#### **Indian Creek Emergency Channel Repair:**

The contractor has begun the removal of the failed wall panel. Construction was postponed due to the multiple storms that the area experienced this past month. Work should be completed by June 12,2015.

#### **Private Development**

### Bear Valley Parkway between Boyle Avenue and San Pasqual Valley Road (County Project):

The contractor has closed the intersection at Idaho Avenue and Bear Valley Parkway to through traffic. The work is proceeding but the reopening of the intersection has been pushed back to June 19, 2015 due to ongoing water line construction. The underground contractor is forming for the new wall footing at Bear Valley Parkway and Boyle Avenue. New concrete curb and gutter is being poured this week on new Bear Valley Parkway between Idaho Avenue and Suburban Hills Drive. Bore pits are being installed for the installation of the next phase of the water main construction under the County water Authority line near Idaho Avenue.

#### 2412 South Escondido Boulevard:

The construction of the new onsite water main is continuing this week.

**Pradera - Lennar Communities:** The demolition of existing structures is ongoing. The truck haul route was approved this week. The project calls for importing 140,000 cubic yards of dirt which will equal 450 truck trips along the approved route. Processing of permits and traffic control are the order of work for this phase of construction.



#### <u>Private Development - Current Plan Reviews</u>

#### Pradera by Lennar (5 Tracts in Lehner/Stanley/Ash block):

Lennar Homes has purchased 5 separate Approved SFD Tentative Maps (Tracts 889, 894, SUB13-0003, SUB13-0010, SUB13-0011) and began processing Final Engr. plans at the start of 2015.

- A combined Rough Grading plan for all 5 Tentative Maps was approved. The Grading Permit has been issued.
- A revised Traffic Study for proposed fill material (145k CY import) haul routes and daily truck trips has been deemed complete and has established the criteria to begin hauling infill.
- The 7 sets of Improvement plans (1-perimeter, 5-onsite for each TM, 1-offsite mitigation) were resubmitted for 2<sup>nd</sup> review and these reviews should be completed this week.
- The Final Map(s) have not been submitted yet.

#### Tract 951 - Jacks Creek Place:

This project is a 12 lot residential subdivision located near Eureka Ranch.

• The 1<sup>st</sup> review of the Final Map, Grading and Improvement plans, and the WQTR was completed and returned to the applicant on 5/27.

#### St. Mary's Community Center:

This project is the 1<sup>st</sup> phase of the St. Mary's Expansion Master Plan. A single large structure behind the existing sanctuary is proposed. Included in this structure is a large multi-use meeting hall, kitchen, offices, a covered basketball/sport court, and large covered patio areas.

- The grading plans were resubmitted (6<sup>th</sup>) by the Engineer on 5/14.
- The WQTR has been approved.
- The Waterline Improvement plans were resubmitted (6<sup>th</sup>) by the Engineer on 5/14.
- A revised Engr. Cost Estimate has been approved and a Bond and Fee Letter was issued on 5/28.

#### **Tract 932 – Hidden Valley Ranch:**

This project is a 179 lot residential subdivision located at the ends of Vista Ave. and Vista Verde Dr. and will connect them when developed. Shea Homes has acquired this project and has begun final engineering.

- A Substantial Conformance Tentative Map was submitted late April and all Depts. have begun review of it and some initial impression comments have been communicated to the applicant with formal review comments expected to be compiled and sent.
- The offsite street improvement plans for the intersection of Vista Ave. & Ash St. were submitted for 1<sup>st</sup> review on 4/23 and this review is expected to be completed in the next week.



 The offsite Traffic Signal plans for the intersections of El Norte Pkwy & Vista Verde Dr. and Ash St. & Sheridan Ave. together with the addition of Traffic Signal plans for the intersection of Vista Ave. & Ash St. were resubmitted for 1<sup>st</sup> review on 5/15 and this review is expected to be completed in the next week.

The purpose of this Information Bulletin (IB) is to inform local enforcement agencies and all stakeholders affected by California building standards of the recent adoption and approval of emergency regulations in the 2013 California Green Building Standards Code (Part 11, Title 24 California Code of Regulations). These emergency regulations were approved by the California Building Standards Commission (CBSC) on May 29, 2015, and are effective **June 1, 2015**. The emergency regulations require water budgets for irrigation of outdoor landscaped areas in <a href="new residential construction">new residential construction</a>. The full text of the emergency rulemaking, developed by the Department of Housing and Community Development (HCD), is included as Attachment A to this IB. #### BACKGROUND

Governor Brown's Executive Order B-29-15 (April 1, 2015) provides a summary of the ongoing drought conditions in California starting with the declaration of a State of Emergency (January 17, 2014), and a Continued State of Emergency (April 25, 2014): citing evidence of a record low snowpack, decreased water levels in reservoirs, reduced river flows, and declining supplies in underground water basins. In addition, the Governor acknowledged that a distinct possibility exists for drought conditions to continue. Further, Executive Order B-29-15 found that conditions of extreme peril to the safety of persons and property continue to exist due to water shortage and drought conditions with which local authority is unable to cope. To address these concerns, Executive Order B-29-15 specified that strict compliance with identified statutes and regulations would prevent, hinder or delay, or mitigate the effects of the drought.

The objectives and individual directives applicable to this rulemaking include focus on saving water and increasing enforcement against water waste. In view of the urgency to conserve California's water resources, as deemed essential by the Governor's Executive Order B-29-15 and prior proclamations, HCD, in coordination with other state agencies, proposed the adoption of these building standards through the emergency adoption process.

# SUMMARY (See Attachment A for complete regulatory text) RESIDENTIAL EMERGENCY REGULATIONS IN THE 2013 CALGREEN CODE EFFECTIVE JUNE 1, 2015:

- A water budget shall be developed for landscape irrigation use that conforms to the local water efficient landscape ordinance or to the California Department of Water Resources' (DWR) Model Water Efficient Landscape Ordinance (MWELO), whichever is more stringent. This requirement applies to permit applications for newly constructed residential structures with landscaping.
- Until the next update of the MWELO by DWR, the following factors shall be used in the calculation of Maximum Applied Water Allowance (MAWA) as addressed in the MWELO.
  - ET Adjustment Factor (ETAF) = 0.55.
  - Special Landscape Areas (SLA) Factor = 0.45. (The resulting total ETAF for SLA shall be 1.0).
- Local agency adoption of MWELO and similar ordinances:
  - The HCD emergency regulations supersede the MWELO and CALGreen residential Tier 1 or Tier 2 (Sections A4.304.3 and A4.304.4). Local agencies will need to modify local ordinances to reflect HCD's changes to ETAF factors, in the MAWA formula.
  - Local agencies who have adopted a local ordinance more stringent than the MWELO will need to verify whether the ordinance will need to be revised to reflect changes in water use allowances resulting from these emergency regulations.
- The MWELO, as codified in the California Code of Regulations, Title 23 Waters,
  Division 2, Department of Water Resources, Chapter 2.7 Model Water Efficient
  Landscape Ordinance, should be consulted for further information on methodology
  and resources needed for compliance with these regulations. See the following

Code users should subscribe to mailing lists for HCD as well as CBSC to remain updated on the status of these emergency regulations.

 HCD proposes new California amendments in Chapter 2, Definitions, for adoption into the 2013 California Green Building Code as follows:

### CHAPTER 2 DEFINITIONS

ET ADJUSTMENT FACTOR (ETAF). A factor that, when applied to reference evapotranspiration (ETo), adjusts for plant factors and irrigation efficiency, two major influences upon the amount of water that needs to be applied to the landscape.

HYDROZONE. A portion of the landscaped area having plants with similar water needs.

2. HCD proposes new amendments in Chapter 4, Division 4.3 Water Efficiency and Conservation, for adoption into the 2013 California Green Building Code as follows:

# CHAPTER 4 DIVISION 4.3 WATER EFFICIENCY AND CONSERVATION SECTION 4.304 OUTDOOR WATER USE

4.304.1 Outdoor potable water use in landscape areas. On or after June 1, 2015, a water budget shall be developed for landscape irrigation use that conforms to the local water efficient landscape ordinance or to the California Department of Water Resources' Model Water Efficient Landscape Ordinance, whichever is more stringent.

The following factors shall be effective until subsequent revision of the MWELO by the California Department of Water Resources (DWR).

- 1. ET Adjustment Factor (ETAF) 0.55.
- 2. Special Landscape Areas (SLA) 0.45. (The resulting total ETAF for SLA shall be 1.0).

- 2. The water budget calculator for use with the 0.55 ETAF is available at: [Web address to be established]
- 4.304.1.1 Methods to reduce potable water use. Other methods to reduce potable water use in landscape areas include but are not limited to:
  - Use of captured rainwater, recycled water, or graywater designed per the California Plumbing Code.
    - a. The use of potable water may be used as a back-up water supply for on-site water recycling and/or reuse systems may be allowed by the Authority Having Jurisdiction (AHJ), provided that it can be demonstrated to the AHJ that the amount of potable water used as back-up in the water recycle or reuse system is less than that which would have been used by other means authorized by the AHJ.
  - 2. Water treated for irrigation purposes and conveyed by a water district or public entity.

**4.304.1.2 Authorized potable water use.** The use of potable water shall be authorized where necessary to address an immediate health and safety need or to comply with a term or condition in a permit issued by a state or federal agency.

4.304.1 4.304.2 Irrigation controllers. Automatic irrigation system controllers for landscaping provided by the builder and installed at the time of final inspection shall comply with the following:

- Controllers shall be weather- or soil moisture-based controllers that automatically adjust irrigation in response to changes in plants' needs as weather conditions change.
- Weather-based controllers without integral rain sensors or communication systems that account for local rainfall shall have a separate wired or wireless rain sensor which connects or communicates with the controller(s). Soil moisture-based controllers are not required to have rain sensor input.

Note: More information regarding irrigation controller function and specifications is available from the Irrigation Association.

## 3. HCD proposes new amendments to Appendix A4, Division A4.3 Water Efficiency and Conservation, for adoption into the 2013 California Green Building Code as follows:

### APPENDIX A4 RESIDENTIAL VOLUNTARY MEASURES DIVISION A4.3 WATER EFFICIENCY AND CONSERVATION

#### SECTION A4.304 OUTDOOR WATER USE

A4.304.1 Low-water consumption irrigation system. Install a low-water consumption irrigation system which minimizes the use of spray type heads. Spray type irrigation may only be used at turf areas. The remaining irrigation systems shall use only the following types of low-volume irrigation systems:

- 1. Drip irrigation.
- 2. Bubblers.
- 3. Drip emitters.
- 4. Soaker hose.
- 5. Stream-rotator spray heads.
- 6. Other systems acceptable to the enforcing agency.

A4.304.2 A4.304.1 Rainwater catchment systems. An approved rainwater catchment system is designed and installed to use rainwater generated by at least 65 percent of the available roof area. Rainwater catchment systems shall be designed and installed in accordance with the *California Plumbing Code*.

A4.304.3 Water budget. When landscaping is provided by the builder, a water budget shall be developed for landscape irrigation use that conforms to the local water efficient landscape ordinance or to the California Department of Water-Resources Model Water Efficient Landscape Ordinance where no local ordinance is applicable.

A4.304.4 Potable water reduction. When landscaping is provided by the builder, a water efficient landscape irrigation-system shall be installed that reduces potable water use. The potable water use reduction shall be calculated beyond the initial requirements for plant installation and establishment. Calculations for the reduction shall be based on the water budget developed pursuant to Section A4.304.3.

- Tier 1. Reduce the use of potable water to a quantity that does not exceed 65 percent of ETo times the landscape area.
- Tier 2. Reduce the use of potable water to a quantity that does not exceed 60 percent of ETo times the landscape area.

Note: Methods used to comply with this section must be designed to the meet the requirements of the other parts of the California Building Standards Code and may include, but are not limited to, the following:

- 1. Plant coefficient.
- 2. Irrigation efficiency and distribution uniformity.
- 3. Use of captured rainwater.
- 4. Use of recycled water.
- 5. Water treated for irrigation purposes and conveyed by a water district or public entity.
- 6. Use of graywater.

A4.304.5 A4.304.2 Potable water elimination. When landscaping is provided by the builder and as allowed by local ordinance, a water efficient landscape irrigation design that eliminates the use of potable water beyond the initial requirements for plant installation and establishment. Methods used to accomplish the requirements of this section must be designed to the requirements of the *California Building Standards Code* and shall include, but not be limited to, the following:

- 1. Plant coefficient.
- 2. Irrigation efficiency and distribution uniformity.
- 3 1. Use of captured rainwater.
- 42. Use of recycled water.
- 5 3. Water treated for irrigation purposes and conveyed by a water district or public entity.

6 4. Use of graywater.

**A4.304.6** A4.304.3 Irrigation metering device. For new water service connections, landscaped irrigated areas more than 2,500 square feet shall be provided with separate submeters or metering devices for outdoor potable water use.
