Escondido Public Library Board of Trustees MINUTES Thursday, January 12, 2012, 2:00 p.m. Library Board Room

CALL TO ORDER: Board Secretary Yerkes called the meeting to order at 2:12 pm.

Cynthia Smith introduced Timmie Gibson, an intern from University of Texas at Austin, who will be here until May 2012 working primarily in the reference department. Donna Feddern introduced Viktor Sjoberg, our new full time permanent digital services librarian. They are very welcome additions to our staff.

WRITTEN/ORAL COMMUNICATIONS: None.

APPROVAL OF MINUTES FROM PREVIOUS MEETING: Greenberg reported that she had confirmed Jack Anderson's statement that Mayor Abed "wants a strong central library" as accurate. MSC Cameron/Gorny to approve the November 2011 minutes as written. Vote 3/0.

BOARD ADMINISTRATIVE ANNOUNCEMENTS: None.

PROJECT UPDATES:

<u>Project Updates</u>: Feddern introduced our new grant project LibraryYou - a university for the people by the people, sharing local knowledge on podcasts and webcasts. This is a way of teaching the public how to communicate in digital formats. These podcasts/webcasts will be added to our catalog for use by the public. If you know of any public groups that might be interested, please refer them to Donna.

Board News/Issues: None.

Reports from Auxiliary Groups: Greenberg reported on the status of Serra and the limited services they can provide. All library directors want to keep the delivery services in place. The second level reference service might be able to work through a website. Serra would develop a database of different experts in libraries and direct second level reference questions to those experts.

The Friends are experiencing a large volume of donations. They will be having a sale about once a month now. Their sales have been very successful.

Pioneer Room Friends received a bequest from the Stockslager Family Trust in the amount of \$13,118.09 and ELEF received a bequest also in the amount of \$65,590.44.

SIGNIFICANT UPCOMING EVENTS: The Board commented on various events.

CURRENT BUSINESS:

<u>Scrabblethon Team Sponsorship</u>: Literacy is asking for the Board to sponsor two teams in the amount of \$240. **MSC Cameron/Gorny to fund the Scrabblethon for \$240, Vote 3/0.** Yerkes commented that the Board is quite happy to do this. Cameron noted that this is a great program and that perhaps we should ask ELEF to fund a team.

<u>PLA Conference</u>: Greenberg asked the Board to approve funding two staff members to attend the conference in Philadephia, PA. The Board discussed going to conferences in general and how beneficial they can be. **MSC Cameron/Gorny to fund the two staff member trips to PLA at a cost of approximately \$1,210. Vote 3/0.**

<u>State Library Update</u>: Unfortunately the trigger bill was pulled and have lost all funding for three different library services, including PLF (Public Library Funding) and literacy services. Greenberg will be attending a meeting later in the month with the state library on how we will keep libraries alive in these difficult economic times. Greenberg explained how this affects our general fund budget because we have projected monies coming in for PLF (the library's operating budget) and the literacy program and we did not receive them.

Library Board Vacancy: The deadline to apply is February 16, 2012.

<u>Strategic Reality Check Workshop</u>: Greenberg reported on her workshop with library futurists. She explained the new way of looking at strategic plans as a community based service. Ask the community "what do you want" from the library vs. what can the library do for you. We will be talking about this approach with our staff and will come back to the Board.

CITY STAFF COMMUNICATIONS:

City Librarian: Caltac is having a Spring 2012 workshop. This is a workshop for Trustees, Friends, etc. Annual State of the City address is February 8th at the CCAE at 8:00 a.m.

Deputy City Librarian: A team of librarians are working on the Collection Policies and updating them. We are also updating our Emergency Procedures manual. We are starting training for our management team in change management. Joanna Axelrod and Lalitha Nataraj are both attending the Dallas conference. The symphony will be here on February 1st. We are also doing ebook training for the public to learn to download library books on the 18th. Our programming is going full steam ahead. Our Fines for Fees program was totally great and we had 132 boxes for interfaith.

Recommendation:

Receive information on Escondido Public Library's role in World Book Night

Background:

World Book Night (WBN) is a charity dedicated to the promotion of literacy and the celebration, sharing and enjoyment of reading among teenagers and adults. More than 50,000 volunteers across the USA, the UK, and Ireland will be giving away free copies of 20 select titles on April 23, 2012 in order to share the joy and love of reading with millions of non-readers in their community.

The Escondido Public Library will be celebrating World Book Night 2012 by serving as a location for book givers to pick up their boxes of free books. Individual staff members will also be serving as book givers. The library will also be hosting a WBN reception for their book givers. A staff subcommittee headed by Joanna Axelrod will be sending out more information on the library's website, http://library.escondido.org in the following weeks.

The deadline to register as a book giver was February 6, 2012. We hope that many people (over 16 years old) have registered and chosen such facilities where they will find light or non-readers such as shelters, detention centers, laundromats, bowling alleys, church, and boys & girls clubs to name a few.

Agenda Item No. 9d California Public Library Summit Report

Recommendation:

Receive March 2011 update and January 17, 2012 Summit Report

Background:

The City Librarian attended the one-day California Public Library Summit January 17, 2012. Library directors from the state came together to build consensus for proactive strategies that will have a continuing positive impact on public libraries and on the people of California.

This was part II; part I, the Sustainability Summit, was held in March 2011.

Library Message Update (this task was chartered during the March 2011 Sustainability Summit)

The purpose of the Library Messaging Project was to craft a compelling message that all librarians can use to speak with one voice. Consultants Joe Rodriguez and Jane Gardner gathered research data for interviews with 20 library stakeholders. The interviews revealed the stakeholders' perceptions about and awareness of public libraries which in turn validated both the need for a fresh library message as well as the need to bring stakeholders into the library. Two concepts that emerged from the research were:

- As a potential long-term vision: "Libraries as a community gathering place for head and heart"
- As a personal benefit for all audiences: "Libraries as a starting place for whatever you need to do next"

As a next step, the State Librarian will contact the library messaging task force about the path forward for continuing the work on the library messaging project.

State Funding for Libraries

Librarians were asked to develop a prioritized list of topics for which the State of California should provide funding support. Participants were provided an opportunity to recommend a topic developed around the following questions:

What specifically should the state fund for public libraries?

Why is this important to the state?

Who will benefit from this funding?

Each topic was presented to all participants. The participants then prioritized the list of ten topics by selecting their **top three topics** based on the following criteria.

"What state-funded topic will have the greatest positive impact on California public libraries?" The top three were:

1. Digitize California Libraries Content

in order to share virtually and preserve precious content.

All Californians will benefit as well as those with challenges in accessing resources, whether physically or geographically.

Start with local history, local stories, unique preservation/access

- Libraries as publishers
- Accessibility for all Californians (example-visual disabilities)
- Workforce development
- Easy win visible results
- Make all content available and accessible to all

2. Technology Infrastructure (Economic and Social Equalizer)

Vital to citizens for equal access and competitive edge

All Californians will benefit including small business, educators, job seekers, health care, tourism.

- Fiber, broadband access
- Must be statewide
- Minimum standards
- The "HUB"

3. Literacy (Digital Literacy, English to Speakers of Other Languages and Every Child Starts School Read to Read)

For the economic stability of the state, a prepared workforce, crime prevention, informed voters, great equalizer, increases the value and competitiveness of the state and country and breaks the cycle of illiteracy. Those who benefit are those who may not fit into traditional and educational institutions

- Literacy for all is a starting point
- Direct effect on economic development
- Learner-centered
