2. REVIEW OF FINANCIAL REPORT

Gil Rojas, Finance, presented the Financial Report for the period ending June 30, 2008. No questions from the Committee regarding the financial report.

3. UPDATE ON POLICE AND FIRE FACILITY

Sam McCuskey, McCuskey Group, reported on the current status of the Police and Fire Facility. Sam reported that the project is about 10 days behind schedule, but they are working hard to keep on the set schedule.

4. UPDATE ON FIRE STATIONS

Fire Station 1: (310 N. Quince)

Framing on the second story has begun. The underground is complete. This project is on schedule and completion is projected to be the end of April or beginning of May, 2008.

Fire Station 3 (1808 Nutmeg):

Fire Station 3 is complete. The punch list is finished. The Grand Opening was held on August 2, 2008, and was well attended by members of our community and city staff. Fire staff is now occupying the station.

Fire Station 6 (1735 Del Dios Road):

Fire Station 6 is about 95-96% complete. Substantial completion should be about October 13th. A Grand Opening will be held in November.

Fire Station 7 (1220 N. Ash Street):

Fire Station #7 is 95-96% complete. Substantial completion should be about September 30th. A Grand Opening will be held in November.

Joyce presented the draft of the Third Annual Report to the Community. Committee Chair Carl Skaja, will present the report to Council at the October 8, 2008, meeting.
