## **REQUEST: SEWER REPAYMENT AGREEMENT FOR RANCHITO DRIVE**

The Laurinda Suzan Barnes Trust Dated December 16, 2020 constructed sewer improvements for the purpose of serving the property at 640 Ranchito Drive, Escondido, CA 92025 ("Property") that will also serve or otherwise benefit, directly or indirectly, three other parcels in the vicinity of the Property and desires to be repaid for a portion of the cost of the improvements from the owners of other benefitted parcels.

# BENEFITED PROPERTY LOCATION: 612, 633, 640 RANCHITO DRIVE AND APN 239-051-10.

**ENVIRONMENTAL STATUS:** The activity is not a "Project" as defined under Section 15378 of the California Environmental Quality Act State Guidelines. Therefore, pursuant to State Guidelines Section 15060(c)(3) no environmental review is required.
